Meeting Opening

- Meeting chaired and called to order at 1:08 pm by Chair Barnes.

AmeriCorps & Legislative Updates

Report out on Federal and State Activities, Presented by Director Bauer

State-Level Updates:

- Director Bauer reported that OregonServes is continuing to align with statewide service and workforce initiatives, including coordination with education and workforce development agencies.
- She noted upcoming legislative opportunities to strengthen AmeriCorps programs in Oregon, particularly around workforce readiness and youth engagement.
- Discussion emphasized the importance of keeping legislators informed of AmeriCorps' impact in communities across the state, especially as Oregon looks to expand support for service pathways.

Federal-Level Updates:

- Director Bauer shared information from AmeriCorps headquarters regarding budget proposals and federal policy direction.
- At the federal level, there are ongoing conversations about funding stability and programmatic priorities, which could affect Oregon's AmeriCorps programs.
- She highlighted that federal agencies are encouraging greater integration between AmeriCorps and state workforce/equity priorities, which may open doors for OregonServes to pursue additional partnerships and funding streams.
- Committee members discussed how these developments could impact future grant cycles and the sustainability of local programs.

Committee Business

Debrief Insights, Address Old Business, and Introduce New Topics, Presented by Chair Barnes

 After brief updates on the agency's strategic planning, Chair Barnes highlighted the need to position the committee as a proactive policy voice within the Commission.

FEDERAL LANDSCAPE

- House proposal would cut the agency roughly in half beginning FY25.
- Senate proposal still pending; better than the earlier draft that proposed eliminating all AmeriCorps programs.
- "America First Corps" name change proposed—unclear whether it applies only to the agency or also to programs.
- OIG is promoting his "successes reducing waste," which could impact perception on the Hill.

SHUTDOWN AND CONTINUING RESOLUTION

- Senate Democrats are seeking a two-year extension of healthcare premium relief.
- A full-year CR is on the table in exchange for healthcare relief.
- Outcome could be:
 - CR through December, or
 - CR through Spring 2026.
- A full-year CR leaves funding flat—better than a shutdown, but not ideal for long-term planning.
- Staff reductions during shutdown: approximately 220 union staff had returned. Now back down to approx. 20-25.
- Most core processes halted or delayed. Website is still offline.

REAUTHORIZATION



Promoting Service through AmeriCorps (PSA) Act

Introduced in September 2024 by Senators Coons (D-DE) and Cassidy (R-LA) as lead authors in the Senate

- "Mini" reauthorization bill:
 - Increases the flexibility of the Segal Education Award to expand workforce development opportunities through service and strengthen the pathway from AmeriCorps to post-secondary education.
 Standardizes administrative flexibilities, eligibility requirements, and
 - Standardizes administrative flexibilities, eligibility requirements, and benefits across AmeriCorps programs to better support members during and after their service terms.
 - Creates more opportunities to serve by authorizing positions with shorter terms of service and codifying an expanded age eligibility range for NCCC.
 - Establishes an Office of Alumni Engagement to strengthen recruitment and foster a common identity among current and former AmeriCorps members.
 - Reauthorizes the national service laws for the period of 2025 to 2029.

COMMISSION INITIATIVES: NGA & YMHC

- Oregon's Youth Mental Health Corps (YMHC) continues to advance despite national program disruptions.
- Had to rebuild partnerships after major turnover and shifting timelines, but:
 - New partners have joined (tribal, rural, and education-based).
 - There's strong interest statewide in serving youth mental health needs through service pathways.
- Progress slowed by federal issues:
 - The NOFO has not been released, preventing new applications.
 - EGrants remains offline, halting submissions and slowing program startup.
- Despite these barriers, OregonServes and partners continue preparing to launch placements, building training and communications infrastructure, and coordinating with Schultz Family Foundation and NGA teams.

STATE SERVICE PLAN ADDENDUM

- **Purpose:** Develop a short-form *State Service Plan Addendum* to meet compliance and capture current priorities for 2025–2026.
- Status: Agreement is in with Procurement. Planning with Kaira next week.
- Schedule: October 31, then two follow-up sessions in November/December.
- Discussion & Considerations:
 - Federal and state funding reductions.
 - Increased partnerships with other state agencies.
 - Consider Oregon's pivot toward state-led service models and future funding diversification.
 - Discuss legislative and policy priorities emerging from Public Policy Committee input.

OPPORTUNITIES

1. Climate and Service Alignment

- Support the development of a Climate Corps model under Oregon's broader service strategy.
- Engage partners across OWI, ODOE, OHA, OEM, and community-based organizations to advance workforce goals tied to climate resilience.

2. HECC Strategy 3 Implementation

- Position service and volunteerism as core tools for civic engagement and applied learning.
- Contribute to solving community problems through partnerships that connect service, education, and workforce pathways.
