6	On or about April 27, 2021, the Oregon State Board of Examiners for Engineering and	
7	Land Surveying (Board) properly served a Notice of Intent to Assess a Civil Penalty (Notice) on	
8	Ira Alan Martin (Martin). The Notice assessed a civil penalty in the amount of \$2000, and it	
9	designated the Board file on this matter as the record for purposes of establishing a prima facie	
10	case upon default. Martin did not request a hearing. Therefore, upon consideration of the facts	
11	and law, the Board enters the following Order:	
12	FINDINGS OF FACT AND ULTIMATE FACTS	
13	1. Martin was a licensed professional engineer	(PE) in Oregon, license no. 72237PE, issued on
14	November 20, 1998, expired on December	31, 2016, and currently in delinquent status.
15	2. On or about January 4, 2021, Martin created	d and stamped engineering drawings for a
16	residential structure in Wasco County, Oregon.	
17	3. Martin provided stamped plans to a client, v	who in turn submitted the stamped plans to Wasco
18	County Building Codes Division.	
19	4. Martin's stamped plans included four pages	s, each stamped with Martin's seal bearing an
20	invalid expiration date of "10/21."	
21	5. Engineering drawings are a professional report.

APPLICABLE LAW 1 1. ORS 672.020(1) provides that in order to safeguard life, health and property, no person shall 2 practice or offer to practice engineering in this state unless the person is registered and has a 3 valid certificate to practice engineering issued under ORS 670.002. 4 2. OAR 820-020-0025(1) provides that registrants and applicants must be objective and truthful 5 and include all relevant and pertinent information in all professional reports, statements or 6 testimony, applications for registration and enrollment as an intern, and references on 7 applications for registration and enrollment. 8 3. Under ORS 672.325(1), the Board may impose a civil penalty of up to \$1,000 per violation 9 without amending its Notice. 10 **CONCLUSIONS OF LAW** 11 1. Because Martin allowed his Oregon engineering licensure to expire he is not licensed to 12 practice in Oregon. 13 2. Because Martin stamped and signed engineering drawings for a client for a residential 14 structure in Wasco County, Oregon, he practiced engineering without a license and thus 15 violated ORS 672.020(1). 16 3. Because Martin wrote a date on his stamp to read "10/21" when his license had in fact 17 expired in December, 2016, and because the engineering drawings are a professional report, 18 Martin was not truthful in a professional report and therefore violated OAR 820-020-19 0025(1). 20 /// 21 /// 22
