Director's Corner

From the desk of Jason Barbee, Board Administrator & Agency Director

As you may recall, in April of 2021, OSBEELS began an 18-month process to review, evaluate, and update qualifications for becoming a licensed land surveyor in Oregon. Our objective was to remove unnecessary barriers to licensure as well as identify alternate paths, while maintaining core competencies. This process involved meeting with various groups, gathering input and feedback from stakeholders throughout the state, and drafting updated rules based on that information. Once we drafted the updated rules, we reached out to those


groups again for another round of input and feedback.

In November of 2022, we implemented our new rules with the alternate paths to become a licensed land survey in Oregon. During our meetings with various stakeholder groups, I committed to tracking the impact these updated rules had on both licensing and regulation (violations), and to share those results.

While it's still a bit too early to truly evaluate the impact these changes have had, the initial results are promising. In

the last 18 months, we have licensed 86 new Professional Land Surveyors, 39 of which qualified under our new rules. In the two years prior to our rule change, we had licensed a total of 58 new Professional Land Surveyors.

Thus far, we haven't had a single violation imposed on any of the new licensees who qualified under the updated rules. We will continue to track data and evaluate the results over the next few years. Congratulations to all of our new licensees!

Q&A: How does OSBEELS define "final documents"?

Answer – OSBEELS has a rule addressing this question. When a registrant puts their seal on documents, they are certifying the documents are complete and prepared under their supervision and control. This is what OSBEELS considers to be "final documents." (OAR 820-025-0015(1))

Furthermore, documents that are not final documents must be marked so the documents are not perceived as

final. Examples of such wording include, "preliminary", "not for construction', "review only", "draft copy, subject to change", or similar wording to indicate that the documents are not intended to represent the final work product of the registrant. (OAR 820-025-0015 (2))

Remember, documents submitted to a client, customer, public entity, or any other person, are considered by OSBEELS as final documents and must bear the seal and signature of the registrant under whose supervision and control they were prepared, unless those documents are clearly marked as not a final document. (OAR 820-025-0015 (2))

If a registrant submits documents to a client or for submittal that do not conform to the above referenced rules, that registrant could be subject to civil penalties under ORS (672.325).

Prior to her position as an Automation Engineer, she was a Roadway Designer in ODOT Region 4 (Central Oregon) for eight years. During that time, she prepared and designed the roadway portion of plans and estimates for a variety of transportation projects, as well as developed the 3D design data required for construction. Using this 3D design data, she also developed project visualizations for her own design projects for internal design concept comparisons, project meetings and external partner presentations. As Jakki explains, "It was this work that sparked

my passion for project visualization development, witnessing first-hand how powerful these communication tools can be for design discussions and public outreach by equitably conveying transportation project design intent and impacts to a wide-ranging audience of diverse backgrounds."

As mentioned, Jakki graduated from OIT in 2012 where she received her bachelor's degree in civil engineering. She believes it was the hands-on educational experience OIT provides that equipped her to succeed in her professional career in the public sector.

Outside of work, Jakki enjoys kayaking, roller skating and hiking with her dogs. Recap: OSBEELS 2024 Customer Survey

n June of this year, we emailed a customer survey to registrants. We want to thank the 1,171 folks who took the time to respond and let you know that our Board and staff reviewed all the responses. We loved seeing that over 90% of the responses were positive feedback and we appreciate the additional constructive feedback that was shared.

It has been two years since we sent out our last survey and a lot has changed since then! We also realize that when our registrants interact with our agency directly, it is likely only once every two years during their renewal period. While OSBEELS is always looking to streamline and improve our processes, it can take time for these changes to be seen by our registrants due to the infrequency most of you interact with us.

Based on the feedback we received from the survey, there were a number of shared themes in the comments that we want to address in this Examiner issue:

Phone Calls – Customer service is a top priority. We received comments stating that some of you had difficulty reaching a staff member when you needed assistance. While our policy is to answer phone calls whenever possible, some calls will inevitably go to voicemail.


We have renewed our commitment to keep our voicemails updated with out-ofoffice information, and to return all phone calls within one business day. If

your call does go to voicemail, be sure to leave a message so we can return your call.

Renewals – There is a new Renewal Guide available on our website to help assist all registrants through the renewal process. It's in a PDF format and can be viewed online or downloaded. We launched the Renewal Guide this last renewal cycle that provides answers to many frequently asked questions, and it has been very successful. CPD/PDH Information – We have created a new page on our website with information to help you navigate your continuing education journey. See our Continuing Education Information page for details.

Audit Process – Based on the feedback received, we have made changes to our audit process and we will continue to



evaluate for additional improvement opportunities. Starting in 2025, if you are selected for an audit, we will first check your most recent renewal for PDH information submitted. If sufficient information has already been uploaded during your renewal, we will not request additional information. You will be notified that the audit of vour PDH information was determined to be sufficient. While registrants must continue to hold verification of their earned PDHs for five years, we encourage folks to upload relevant documentation during their renewal process to save time in a potential audit.

Once again, thank you for sharing your experiences! We will continue conducting an annual survey and your feedback is essential in helping us help you.
