# Protecting One's Own Life During an Event in the Workplace That Could Reasonably Be Expected to Cause Death or Serious Physical Harm

### Background

An event such as a natural disaster, chemical spill, active shooter, fire, explosion, etc., albeit rare, is a potentially deadly event that can happen anywhere at any time. The Board recognizes that such an event can happen when a licensed nurse or certified nursing assistant (CNA) is on the job working with clients.

#### **Board Statement**

There exists no Oregon Revised Statute or Oregon Administrative Rule within Oregon's Nurse Practice Act that places a legal requirement on the nurse or CNA to sacrifice their own life or personal safety over that of their client during an event in the workplace that could reasonably be expected to cause death or serious physical harm.

In the event someone was to report a nurse or a CNA for failing to protect their client during a situation as described above, an investigator would validate the fact pattern related to the specific complaint to determine whether the complaint falls into the Board's regulatory jurisdiction.
