PUBLIC SESSION

ADDITIONS, MODIFICATIONS, REORDERING OF AGENDA

There were no requests for additions or modifications to the agenda.

ADMINISTRATION

A1. Phasing Out of Emergency Declaration Procedures

Executive Director Ruby Jason explained that since the last Board meeting, information has been gathered regarding the status of the education programs and facility staffing as a result of COVID restrictions being lessened.

On June 30, 2021, Governor Kat Brown announced the lifting of all remaining COVID-19 health and safety restrictions with the exception of those restrictions of health care facilities, public transit, and airports, and declared that Oregon business was 100% open. In further conversations with the HealthCare Policy advisor from the Governor's office, if was communicated to the agency that while some restrictions were lifted, the overall COVID-19 strategy would remain in place until at least the end of December 2021. Therefore, the Board's authority to extend any rules intended to provide COVID relief to education programs, facilities, and licensees would continue. To determine the needs of the community, Board staff solicited feedback from education program directors and facility Chief Nursing Officers. For facilities, there are significant shortages in nursing personnel at the CNA, RN, and LPN levels in all context of care. Fallout from the fifteen months of the public health care needs resulting from COVID have led to burnout, resulting in requests for extended vacations, resignations, and retirement, which has led to staffing shortage, particularly at the CNA level in long-term care, and at the RN level in acute care facilities. Methodology for budgeting the staffing of nursing personnel remains static, while the requirements at the bedside continue to escalate.

There are currently 469 nurses working under the emergency authorizations implemented by the Board. These include nurses not only directly caring for COVID patients, but also backfilling needed for time off for regular staff, allowing preceptors to orient and onboard new graduates, and replacing nurses entering into retirement. To end the authorizations now would exacerbate an already dire situation and be detrimental to the Board's mission of public safety. To date, since the beginning of the emergency authorizations, there has been no Oregon originated complaint regarding the practice of nurses who have entered the state under the authorizations.

Throughout the COVID response, long-term care facilities have utilized the statutory exemption of ORS 678.034, which allows nurses to begin work on the day the Board receives a complete application. The exemption is valid for 30 days, with a single extension for an additional 30 days while awaiting the issuing of a permanent Oregon license. The exemptions are also available to Emergency Departments, Critical Care, and Cardiac Units; however, there is higher utilization of the exemptions in long-term care. The statutory exemption is not available for CNA staff; however, the Board-implemented emergency authorizations are open to CNAs. Board staff recommended that the Board continue these authorizations until the Board receives feedback from facilities that would indicate that continuing to waive the licensure requirements outweighs the current public safety implications of staffing.

The Oregon Health Authority is attempting to fill vacancies in long-term care with the "temporary patient care assistant." Board Policy Analyst Debra Buck previously presented information to the Board regarding this category of healthcare workers that are used to help mitigate the long-term staffing shortages.

For education programs, the term "education program" is applicable to undergraduate education and CNA programs based in Oregon. Education programs are experiencing the effect of the current staffing situation, clinical experiences are cancelled due to a lack of student preceptors, and the need for preceptors to orient new hires is taking precedent over the need to precept students. Other issues facing nursing education is the number of appropriately educated nurse faculty, which has always been an issue in nursing education and may take several years to recover from the effects that the COVID response has had on all Board licensees and certificate holders.

How to address the education of students through the COVID response has been a challenge. Utilization of simulation has been a mainstay of the educational programs' COVID response; however, the quality of simulation varies based upon available facilities and faculty. The present research regarding simulation replacing clinical placements is that 49% of direct clinical experience may be replaced by effective simulation. If all education programs were to provide the same level of simulation, this 49% decrease and need for preceptors could have a significant impact on the facilities' abilities to provide preceptors for the students who are still requiring facility placements. Since all simulation programs are subject to appropriate equipment, facilities, and faculty expertise, not all programs will be capable of replacing the 49%.

Board staff recommended that the Board maintain all current emergency waivers for programs to maintain online didactic and simulation until, at a minimum, December 31, 2021, at which time Board staff would contact the education programs to determine current status. To be able to provide facilities and education programs with continued options to address their respective issues would be in the best interest of the public.

Direction from the Board to Board staff to continue waivers and special consideration for COVID per Board staff recommendations. There was Board discussion regarding the end of the year timeframe related to educational programs. Addition direction to Board staff to continue to gather data and information from educational programs and provide to the Board at the November Board meeting and, contact the Governor's office regarding extending parts of the emergency declaration after December 31, 2021, if necessary.

Board Member Caddy announced that the National Council of State Boards of Nursing (NCSBN) NCLEX® testing capacity resumed to 100% as of June 30, 2021.

EXECUTIVE SESSION
