



Continuing Education Requirements for Renewal

As of January 1, 2026, practice hours will no longer be required for Oregon licensed nurses or certified nursing assistants and medication aides. Going forward, continuing education hours will be used to assure competency.

AS OF JANUARY 1, 2026

LPN, RN, or APRN Renewal Applicants:

CMA Renewal Applicants

- **Eight hours of continuing education** related to medication aide authorized duties.

As of January 1, 2028:

LPN, RN, or APRN Renewal Applicants

When renewing a nursing license, the following applies:

- LPN or RN applicants: 20 hours of continuing education within two years.
- CNS applicants: 75 hours of continuing education within the last five years.
- Nurse emeritus applicants: 10 hours of continuing education within two years.
- CRNA or NP applicants: Holding current national certification fulfills the continuing education requirement. Please note that Pain Management and Cultural Competency education is still required. See below.
