



LIMITED FIREWORKS OPERATOR CERTIFICATION Checklist

This checklist has been provided to assist in completing your application. It is not an all-inclusive list; it is to bring attention to the areas that are frequently overlooked.

1. Applicants are required to certify their knowledge of Oregon's Revised Statutes (ORS) 480.130 through 480.150, Oregon Administrative Rules (OAR) 837-12-0700 through 837-12-0970, and safety procedures for displays.
2. Renewal applications must be received by OSFM 90 days prior to the expiration date on the certificate.
3. Complete the application form.
 - a. Do not use "same as before" or "same as above".
 - b. Please include your email address for quicker response times.

A **LIMITED FIREWORKS DISPLAY** is a display held outdoors and limited to Class “C” fireworks. Quantities of firecrackers, skyrockets, missile rockets, helicopter spinners, mortars, and similar items are subject to limitation by the fire authority having jurisdiction. See OAR 837-12-0720(27).

Applicants are required to certify their knowledge of Oregon’s Revised Statutes (ORS) 480.130 through 480.150, Oregon Administrative Rules (OAR) 837-12-0700 through 837-12-0970, and safety procedures for displays. To meet the certification requirements, read the above referenced statutes and rules and complete and return this Application to the Office of State Fire Marshal.

Renewal applications must be received by the State Fire Marshal 90 days prior to the date certification is expiring.
