# THE SECRET INGREDIENT IS FIRE SAFETY THIS HOLIDAY SEASON



#### **FRY IT RIGHT**

- Never use a deep fryer on a wooden deck, under a patio cover, in a garage, or in an enclosed space.
- Fryers should only be used outdoors on a sturdy, level surface isolated from anything that could burn.
- Keep children and pets out of the 3foot radius around your fryer to protect against burn injuries.
- The pot, lid, and handles of a turkey fryer can be incredibly hot. To protect hands and arms against burns, wear long, well-insulated cooking gloves.
- Keep an <u>all-purpose fire extinguisher</u> nearby, and never use water to extinguish a grease fire.
- Make sure the turkey is completely thawed and thoroughly dried before it is placed in a fryer. The water from a frozen turkey will not mix with the oil in the fryer and can be an explosion hazard.

The holiday season is fast approaching, and Oregon families will be coming together for a time of celebration. The hours spent in the kitchen preparing turkey, mashed potatoes, pies, and all the other fixings come with an increased risk of household fires.

Here are ways to keep you and your family safe in the kitchen this holiday season.

#### Safety tips to remember when cooking:

- Keep an eye on what you're cooking; don't leave cooking unattended.
- Keep cooking areas clean and clear of combustibles (potholders, food packaging, towels, etc.) and wipe up surface spills.
- Create a three-foot kid- and pet-free zone around the stove.
- Older children should only cook with permission and under the supervision of an adult.
- Have a lid or cookie sheet within reach while cooking to smother flames in case of a fire.

#### Safety tips for if a cooking fire does start:

- Put a lid on it! Slide a lid over the pan from the side, then turn off the burner.
- Don't move the pan until the fire is completely extinguished and cooled, and don't try to transfer the pan to the sink.

#### If you cannot extinguish the fire:

- Get yourself and your family safely out of the house.
- If you can, close doors as you escape to help contain the fire.
- Call 911 from a safe place outside.





# TEAM SENT TO HELP WITH HURRICANE IAN RETURNS HOME

The 13 incident management team members sent to Florida to help with Hurricane Ian's response and recovery returned home on October 13. The team was in Hardee County, Florida for two weeks and helped emergency managers and the sheriff's office with logistics, planning, communication, and other tasks.

On September 28, the OSFM mobilized the team following the Florida Division of Emergency Management's request for aid through the Emergency Management Assistance Compact (EMAC), administered by the Oregon Department of Emergency Management. The OSFM immediately went to work to fulfill the request. The team was led by Incident Commanders Ted Kunze and Ian Yocum.

"We are thankful to the Oregon fire service and our all-hazard IMTs for answering the call to help Floridians," Oregon State Fire Marshal Mariana Ruiz-Temple said. "I want to thank the team members, their families, and the Oregon fire service for supporting this mission. Our IMT members train year-round to be prepared to assist in any emergency or disaster, including hurricanes. Our office stands ready to help protect lives and communities. We are keeping those in Florida impacted by this storm in our thoughts."

Hardee County was hit hard with flooding. The storm knocked out power to 99 percent of the county. Working alongside their partners in Florida, the team was able to help coordinate recovery and put communities on a successful path forward. The OSFM is proud of this team and their dedication to helping others.

## DEADLINE FOR OREGON FIRE SERVICE CAPACITY PROGRAM APPROACHING

Applications for the Oregon Fire Service Capacity Program are due on November 30, 2022. The grant program is intended for small to medium-sized agencies that have a need for increased permanent firefighter and/or fire prevention staff.

This competitive grant opportunity is available to local fire agencies in Oregon. These agencies can apply for funds to support up to two firefighters and two fire prevention staff over the next three years.

This grant program aims to increase local onduty capacity through the next three years. The OSFM has a two-pronged approach to preparing and protecting Oregonians from wildfire by boosting the capacity to mobilize and respond to fires at the local, regional, and statewide level and preparing communities to be more resilient to wildfire.

### DEFENSIBLE SPACE STANDARDS UPDATE

In October, the OSFM wrapped up a series of 20 town halls, 17 in-person around the state and three virtual. These valuable opportunities to meet are helping shape what the future of defensible space looks like in Oregon. Roughly 2,000 people attended to share input, information, and perspectives we value.

Through Senate Bill 762, our office was tasked with developing defensible space standards using a transparent and open process.

The goal is to create <u>defensible space standards</u> that better protect against wildfire, are inclusive, and reflect all Oregonians.

Overall, there was a positive response to defensible space as a practice. Most Oregonians are familiar with wildfire and understand the importance of having proper defensible space and protecting their properties for fire season.

The OSFM received helpful comments about area-specific ways to accomplish defensible space work and how to create a more wildfire-resilient Oregon. For example, property owners asked about getting help from bucket trucks and arborists to limb tree branches near their homes. Community leaders requested funding to rent chipper machines to remove debris and vegetation from citizens' yards and community spaces.

Because of the revised timeline for aspects of Senate Bill 762 and the Oregon Department of Forestry's (ODF) wildfire risk map, the adoption of defensible space standards is postponed until the final version of the wildfire risk map is released.

Between now and the release of the new map, the OSFM will educate Oregonians about defensible space best practices and wildfire preparedness. In addition, the OSFM is developing tools and services for property owners looking to create defensible space.







#### OSFM, PARTNERS HOST WILDFIRE DISCUSSION IN WASCO COUNTY

Thank you to everyone who attended and took part in the Wildfire in Wasco community event in Wamic on October 22.

The event was an example of partnerships between the OSFM, local fire agencies, ODF, and the USFS. The event was a way to share with local communities the different things they can do to better protect themselves and their property from wildfire.

The first 30 attendees received an evacuation kit; 55 people attended the event at the Wamic Grange.

Sign up today for the upcoming Assessing Structure Ignition Potential for Wildfire (ASIP) course. This is a free NFPA training that discusses wildfire behavior, structure exposure, the concepts of the home ignition zone, and structure ignition potential. This training is designed to increase understanding of wildland-urban interface fire mitigation, show how to assess risk to individual homes, and recommend proper mitigation measures.

These courses include a half-day field exercise, weather, and location permitting, where students will get hands-on experience putting their new knowledge into practice.
