Any business that rents any type of motorized or non-motorized boat to another person is considered a Boat Rental Business (Livery) and requires registration with the Oregon State Marine Board. There is no fee for a Boat Rental Business registration. (ORS 830.425)

Motorized Rentals: If renting 5 or more motorized boats , to receive a reduced registration rate of \$13 per boat instead of the normal rate, you must pay a biennial fee of \$90. Your boats must be titled and registered under the livery name to qualify for the reduced registration rate. Include a check or money order for \$90 with this application to receive the reduced rate.			
Non-motorized Rentals: Once you've registered as a Boat Rental Business, you will be eligible for discounted Waterway Access Permits for non-motorized boats. You must apply for Waterway Access Permits separately from this application.

Yes	As a Boat Rental Business operator, I will:
<input type="checkbox"/>	Ensure all vessels are properly equipped. (ORS 830.410)
<input type="checkbox"/>	Create and maintain for at least 6 months, a written record of each person who rents any type of boat, an ID of the boat, the date and time of the rental departure and return. (ORS 830.415)
<input type="checkbox"/>	Maintain on file for inspection all certificates of number for registered boat, ensure all boat are clearly marked as rentals, and the rental operators have signed a rental/lease agreement containing the boat ID, and the time period of the rental/lease. (ORS 830.770)
<input type="checkbox"/>	Equip any Personal Watercraft (PWC) I may rent/lease with the proper life jackets for each person that will ride the PWC. I understand that inflatable life jackets are not acceptable for PWC use. I will equip all PWC with the proper safety equipment including a safe operation decal. (ORS 830.210, 830.410, 830.420(2), and OAR 250-021-0030)
Watercraft Rental Safety Checklists - for rental of motorized boats over 10Hp	
Yes	I will provide for each customer the appropriate Rental Safety Checklist, where I will:
<input type="checkbox"/>	Ensure every person renting a motorized boat has provided proof of being issued a Boating Education Card or has reviewed, signed, and dated a watercraft rental safety checklist.
<input type="checkbox"/>	Retain the portion of the checklist with the customer's and my signatures and be able to present them for inspection at the request of any law enforcement. (ORS 830.415)
<input type="checkbox"/>	Ensure the watercraft rental safety checklist is always carried by the vessel operator and be presented to law enforcement when requested during the rental period. (OAR 250-018-0060)
