



Waterway Access Permit Commercial Permit Application Form



In Oregon, manually powered boats must carry a Waterway Access Permit when operating. Funds generated by the fee go towards statewide grants for non-motorized access points, education, and aquatic invasive species prevention efforts designed to protect Oregon's waterways, fisheries and the environment.

If you operate a commercial business that uses manually powered motorized boats (such as Oregon Outfitter Guides or Boat Liveries), you may use this form to order your Waterway Access Permits. If you own six or more boats, then you may qualify for the discount permit rates outlined in ORS 830.575.

Boat Livery

ORS 830.005 defines "Operator of a boat livery" as "any person who is engaged wholly or in part in the business of chartering or renting boats to other persons."

A. Liveries do not include clubs or organizations where a membership fee or partial ownership entitles a user to club-owned boats.

B. Livery boats must be marked with the name of the company
