Lienholder (Security Interest Holder / Lender): Must include line stamp, signature and date or a separate lien release letter on lender letterhead.

FEES:

Replacement Title NO change of ownership or lender: \$25

Title with any ownership change or removal of lender: \$50

Late Fee: Last Title Holder(s) signature more than 30 days from the date submitted to the Marine Board \$25

Registration if not current: Boats of any length or type of motor and sailboats 12 feet and longer must be titled and registered to be legally used in Oregon waters. Registration = \$4.50 per foot, rounded up plus a \$5 Aquatic Invasive Species fee. Length = center length, bow to stern. Example: 11' 1" = 12' x \$4.50 + \$5 = \$59.00.

SPECIAL INSTRUCTIONS:

1) Certified / Return Receipt Mail:

- Fill in the vessel data information.
- Print the former owner, co-owner and lender in the middle section of the form. Make a copy of the form to mail.
- Write a letter to the former owner(s) and lender stating you have purchased the boat without a title and need their release of interest signatures on the form.
- Mail the letter and form to owner(s) and a second letter to any lender as Certified Mail, Return Receipt Requested at your local post office.
- The Post Office will return it to the sender if undeliverable. Send the unopened letter(s), your application as new owner, an original Bill of Sale, and check or money order payable to OSMB for the fees.
- If the green Return Receipt card is returned with a signature, but the form is not returned within 30 days, send the Return Receipt with your application as new owner, an original Bill of Sale and a check or money order payable to OSMB for the fees.

2) Owner(s) divorced or deceased:

- Divorce, the final divorce decree: first page, page awarding the boat and signature page including judge's signature.
- One owner is deceased and the title was issued with a co-owner, a copy of the death certificate or obituary must be submitted. If the surviving spouse is a step parent, an Inheritance Affidavit* may be required.
- Both owners are deceased, copies of death certificates or obituaries must be sent with the following:
 - Personal Representative – a copy of the court documents appointing the personal representative.
 - Will – copy of will and Inheritance Affidavit.
 - Small Estate Affiant – court document recorded at county of death.
 - Trustee – a certification of trust or pages of the trust appointing a trustee or successor trustee.
 - No will, estate not probated – Inheritance Affidavit.
