- Write a letter to the former owner indicating the title is lost and you need their release on the form.
- A good attempt to obtain proper releases must be made by mailing a copy of the form and the letter Certified Mail Return Receipt requested.
- Be sure to address the letter to ALL former owner(s) and or lender (if any).
- If the letter is returned unopened, submit the unopened letter with your application and fees.
- If the letter is signed for and you receive the signed receipt card, wait 30 days for a response. If none, submit the signed receipt card, application and fees.
- If they sign for the letter and you received the releases, submit the signed form with your application and fees.
