

COMMUNITY OUTREACH



East Region Shop with a Cop Events

Officers with the Baker City Police Department and the Baker County Sheriff's Office assisted as well. Twenty-five kids in total participated in the event.

The east region Fish and Wildlife Lieutenant and a La Pine Trooper also assisted with the annual Shop with a Cop event in Redmond. The event, as always, was a great time for local city, county, and state law enforcement agencies, and most importantly, the youth involved.

A Klamath Falls Fish and Wildlife Trooper spoke to a local 2nd grade class about working for law enforcement and being a Fish and Wildlife Trooper. The class got to check out his patrol truck, some animal parts, and some of the equipment utilized by OSP F&W.

Troopers Present at OHA Meeting - McMinnville

McMinnville Fish and Wildlife Troopers presented as the guest speakers for the Yamhill County Chapter of Oregon Hunters Association (OHA). The Troopers summarized enforcement activities throughout the past year. Many questions were fielded regarding local hunts, regulations, and various enforcement issues. Approximately 15 people were in attendance.

Sergeant and Trooper Attend OHA Horn Night

A Central Point Fish and Wildlife Sergeant and Grants Pass Trooper attended the Josephine County OHA Dinner and Meeting. About 20 people were in attendance for the annual "Horn Night" with four successful deer hunters willing to show off this season's take.

The Dalles Meat Donation

A Fish and Wildlife Sergeant and Trooper made a large donation of deer and elk meat to the Salvation Army in The Dalles. This donation came at a critical time for the donation center as funding was down and their sources of protein to hand out to families for meals was very low.



Multiple Agencies Assist with Toy Drive

A Hermiston Fish and Wildlife Trooper volunteered delivering gifts to multiple children's hospitals, Ronald McDonald Houses, and various charities throughout Oregon and Washington for the 5th annual Jasmine Strong Toy Drive. The toy drive is led by Detective Ellwood with Umatilla County Sheriff's Office (UCSO) and his daughter Jasmine, who is a cancer survivor. UCSO, Walmart, Washington State Police, Yakima County Sheriff's Office (WA), Richland Police Department (WA), Lacey Police Department (WA), and multiple additional agencies participated in the two-week endeavor collecting, sorting and delivering nearly 1000 boxes filled with gifts and over 40 bikes.

GENERAL LAW & RESCUES



Great Horned Owl Rescued from Fence

A Fish and Wildlife Sergeant from The Dalles responded to a call from a local landowner who located a great horned owl caught in his barbed wire fence. The owl was carefully removed from the fence by the Sergeant and transported to Rowena Wildlife Clinic due to its injuries. The clinic reported that the prognosis was positive and was hopeful the owl would be able to be released to the wild after healing.

Wanted Man Refused to Exit Rogue River

Central Point and Grants Pass Fish and Wildlife Troopers were requested to launch a jet boat in Gold Hill at the Sports Park to assist with the arrest of a man in the Rogue River. Jackson County Deputies had a subject with warrants refusing to exit the river. Jackson County Marine Deputies, Fire Rescue, and OSP Fish and Wildlife responded with jet boats and were able to assist. Due to recent heavy rains the Rogue River was rising, cold, and full of debris. The subject was taken into custody without incident.

Trooper Helps Travelers During Winter Storm

A Burns Fish and Wildlife Trooper responded to a vehicle slide off on US-78 near milepost 58 during a snowstorm in the Steens area. Upon arrival the Trooper was able to call a tow truck for the occupants. While on scene, the Trooper went up the hill for better radio coverage and came upon a stalled commercial motor vehicle (CMV) sideways blocking all lanes of travel. There were also several other stalled vehicles because of the icy roads. The Trooper was able to help several vehicles get turned around and on their way. ODOT and another Fish and Wildlife Trooper arrived on scene later to assist with the snow-covered pass and stalled motorist.



Abandoned Dogs Rescued - Multnomah County

A Portland Fish and Wildlife Trooper was patrolling in rural Multnomah County when he encountered three pit bulls running in the roadway. One adult mother and two puppies. The dogs did not have collars and it appeared they were abandoned. The Trooper was able to get the two puppies into the bed of his truck but the mother kept her distance. Multnomah County Animal Services arrived with treats and all dogs were captured.

Driver Arrested for DUII and Firearm Charge

A Baker City Fish and Wildlife Trooper contacted a suspicious vehicle parked along SR-245, near SR-7. Multiple signs of impairment were observed, and the driver refused standard field sobriety tests (SFSTs). The driver was arrested for Driving Under the Influence of Intoxicants (DUII), transported to the jail, and provided a breath sample showing a blood alcohol content (BAC) of 0.29%. A search of the vehicle yielded the seizure of a concealed handgun. The driver was cited and released for **DUII: Alcohol** and **Unlawful Possession of Firearm.**

GENERAL LAW & RESCUES



OSP and ODFW Rescue Tangled Elk Calf

A Springfield Fish and Wildlife Sergeant responded to an elk calf stuck in a fence. When he arrived, he saw the elk's front legs were tangled in the barbed wire fence and the property owner had covered the elk's face with a blanket, so the elk was no longer struggling. He relayed the information to the Oregon Department of Fish and Wildlife (ODFW) and they responded. The ODFW employee cleaned the elk's wounds, and the property owner gave permission to cut the fence. The Sergeant and the ODFW employee worked together to restrain the elk and the fence was cut. The elk was freed and ran into the field. A Fish and Wildlife Trooper arrived on scene and ensured the elk did not try to jump another fence. The elk calf ran into the timber in the direction the elk herd had gone.



Drunk Driver Flees from Traffic Stop

A Salem Fish and Wildlife Trooper overheard dispatch airing an active disturbance at Silver Falls State Park involving two subjects who were highly intoxicated. The two subjects were contacted by a State Park Ranger when one of the subjects became highly aggressive with the Ranger. The Trooper was the in the area investigating an elk case and was the closest Trooper to the area. While en route the Ranger reported the subject had left the area. The suspect vehicle drove past the Trooper who followed, observing their driving. Numerous moving violations were observed and the vehicle almost left the roadway at one point. The Trooper initiated a traffic stop and the vehicle slowed and signaled before failing to yield and eluding. The Trooper disengaged and stopped while observing the vehicle turn into a residential driveway within sight. The Trooper then observed a female driver and male passenger getting out of the vehicle from the entrance to the driveway. A Salem Patrol Trooper arrived and the two subjects were contacted. The driver showed signs of impairment and refused standard field sobriety tests (SFSTs). The driver admitted to seeing the Trooper's emergency lights and stated she believed they were "Christmas lights" before realizing they were in fact, police lights. The driver was arrested for Driving Under the Influence of Intoxicants (DUII) and an analysis of breath showed a blood alcohol content (BAC) of 0.26%. The vehicle was towed from the scene and the driver was lodged at the Marion County Jail on DUII: Alcohol and Fleeing or Attempting to Elude Motor Vehicle.

Subjects Located with Stolen RV

A La Pine Fish and Wildlife Trooper assisted Bend Police Department and Deschutes County Sheriff's Office personnel with locating two wanted subjects that were associated with a stolen truck and trailer located near Fall River. The subjects were located in Sunriver and taken into custody on multiple active warrants and charges of Unauthorized Use of a Motor Vehicle (UUMV) and Theft of RV

Trooper Clears Tree Blocking Road

A Roseburg Fish and Wildlife Trooper was headed out to check elk hunters when he came across a fir tree blocking a main county road. The Trooper utilized his department issued chainsaw to remove the hazard.


WILDLIFE & ENVIRONMENT



Subjects Cited for Taking Deer Head

A Klamath Falls Fish and Wildlife Trooper investigated a buck found headless in a canal. The business directly adjacent to the canal was contacted and found to have excellent video surveillance. The business owner located video that showed a truck drive down the canal, three individuals got out, with two of them walking down the canal. Two of the subjects came back up the bank several minutes later with the buck's head, placing it in the truck. A few days later the Trooper contacted the truck owner at his residence, and a full confession was obtained. The subject was cited for **Unlawful Possession of Game Parts** and the antlers were seized. The subject's father assisted in taking the dead head, and he was also contacted and warned for **Aiding in a Wildlife Offense.**





Buck Poached with Rifle During Archery Season

A Fish and Wildlife Trooper received information regarding a large Mule Deer buck that had possibly been shot in the Whitehorse Unit by a male subject with a Beatty's Butte unit archery tag. Troopers interviewed the witnesses and reporting individual who came forward and turned the case over to OSP. The male subject was located working on a ranch in Harney County. He initially denied shooting the buck unlawfully, but ultimately confessed to not only shooting the trophy buck in the Whitehorse Unit, but also shooting it with a rifle to put it down so it would not run onto private property and die. The head/antlers, meat, bow/arrows, and rifle were seized for evidence. The male subject was issued criminal citations for Unlawful Take/Possession of Buck Deer, Hunting Outside of Unit Boundaries, and Hunting Prohibited Method.

Subject Cited for Taking Spike Elk Closed Season

A Springfield Fish and Wildlife Sergeant went to a residence in Eugene to interview a subject after an Astoria Fish and Wildlife Trooper advised the Sergeant the subject had recently killed a spike elk in Clatsop County during an antlerless elk hunt. The Trooper was able to identify the hunter by using trail camera footage from the landowner and the antlerless elk hunt list from the Oregon Department of Fish and Wildlife's Electronic Licensing System (ELS). When the Sergeant arrived at the subject's house, he found him in the process of packaging elk meat. The Sergeant interviewed the subject and he admitted to killing the spike elk in question in Clatsop County. He was criminally cited for **Taking Spike Elk Closed Season** and the meat was seized.

WILDLIFE & ENVIRONMENT



Trophy Buck Poached at Night with Spotlight

A Klamath Falls Fish and Wildlife Trooper observed a subject boiling out a deer skull alongside his residence. The Trooper contacted the subject and found he was an aspiring taxidermist doing European skull mounts. A taxidermy check was conducted, and a large mule deer buck with fresh meat and hide was found. The taxidermy record only had a name on it and no tag information. A check with the ODFW Electronic Licensing System (ELS) showed the responsible party did not have a deer tag for 2023. The deer was seized, and the Trooper went to the suspect's address and interviewed him. The subject admitted to shooting the large buck at night with the use of a spotlight. The buck was killed several days prior to Thanksgiving with the assistance of a friend running a 12v spotlight out the window of his truck. The two subjects then cut the head off the buck and left the body to waste. The two subjects were criminally cited for Unlawful Take Buck Deer and Hunting with the Aid of Artificial Light.

Subject Cited for Dumping Trash Near River

An Albany Fish and Wildlife Trooper was contacted by a local landowner and provided with a video of individuals dumping garbage near the Luckiamute River inside the Travel Management Area (TMA). The vehicle was located at the at Coffin Butte Landfill and an occupant of the vehicle admitted to the dumping. The subject was criminally cited and released for **Depositing Trash Within 100 Yards of a Waterway** and **Violating the TMA**.

Hunter Accidentally Takes Spike Elk

A Newport Fish and Wildlife Trooper received a report from a hunter who had shot a spike elk while attempting to take a cow. Troopers responded to the scene. At the close of the investigation, the elk was seized, and the hunter was issued a warning for **Unlawful/Take Possession: Spike Elk.** The elk was donated to the Lincoln County Food Share.

Guide Cited for Hunting Crimes

A John Day Fish and Wildlife Sergeant received a complaint from a landowner in the Ritter area of a hunting guide and other subjects who had trespassed on their property, and who had likely shot a cow elk. The Sergeant and a Trooper met the victim landowner at first light the following day and conducted the investigation. Interviews were conducted as well as scene examination. The investigation revealed that an adult hunting guide from a local outfitter had two paying clients who had valid Northside-Ritter private lands cow elk tags. The guide and clients, along with the guide's friend, trespassed onto the victim's property and both clients shot at a herd of elk, killing one cow elk. A UTV was then used to trespass onto the property and retrieve the elk. The guide was criminally cited for Criminal Trespass II, Aid/ Counsel in Wildlife Offense (Unlawful Take Elk), and Aid/Counsel in Wildlife Offense (Hunt in Violation of Criminal Trespass). Based on the clients relying on the knowledge of the guide, they were not charged. A Fish and Wildlife Trooper from Ontario assisted in the case, seized the cow elk and transferred it to the John Day Trooper for donation to the Grant County Food Bank.

Unlawful Take of Bobcat - Hood Unit

A Fish and Wildlife Trooper from The Dalles received an anonymous tip that a subject was using traps in the Hood Unit without having a furtaker's license. They also mentioned that the person may have taken a bobcat with those traps. The Trooper checked through ODFW, and the subject did not have a valid 2023 furtaker's license. Through investigation, the Trooper was able to obtain a photo of the subject holding up a bobcat in a photo. The Trooper contacted the subject in question the next day for an interview. The subject admitted to trapping and killing a bobcat without the proper licensing. He stated that there were three traps in the set and the traps belonged to his friend who had a valid 2023 furtaker's license. He stated even though he killed the bobcat, his friend put it on his harvest card. The subject was cited for Unlawful Take of Bobcat Without a Valid Furtaker's License. The friend was interviewed, and it was verified he had a valid 2023 furtaker's license. He was cited for Loaning/Borrowing a Bobcat Harvest Card. The bobcat was seized. The traps were checked for the proper branding and were found to be legal traps.

MARINE FISHERIES TEAM



Commercial Dungeness Crab Opener

The commercial Dungeness crab season opened south of Cape Foulweather to the Oregon/CA border on December 16. Marine Fisheries Team Troopers conducted patrols both on the water and dockside.

- A Trooper on the south coast performed two ocean boat patrols in Curry County during the commercial Dungeness crab opener. Compliance was high and no enforcement actions were taken.
- During commercial crab hold inspections in Port Orford, a Trooper cited two commercial skippers for Failing to Maintain/Submit Commercial Crab Logbooks for the 2022-2023 season. Both skippers failed to turn in any logbook pages for the season.
- A Sergeant was on an ocean patrol out of Newport and found a vessel that started pulling their gear prior to the 9:00 am start time. The vessel was boarded and they said they thought the start time was at 8:00 am. The captain was instructed to pump out the hold and all crab retained prior to the opening of the season were returned back into the ocean. The captain was cited for **Commercial Fishing Closed Season.**

Subject Exceeds Weekly Landing Limit

A Gold Beach Fish and Wildlife Trooper followed up on a commercial sablefish overage investigation, where a fisherman had exceeded the weekly landing limit by 2,977 lbs. The suspect told the Trooper he didn't know what day the cutoff was for a "week," so he just guessed and guessed wrong. The subject was issued a citation for **Exceeding a Cumulative Trip Limit.** The landing was seized.

Dealer Cited for Failing to Record Deadloss

A Newport Fish and Wildlife Trooper observed an offload of commercial Dungeness crab to a wholesale fish dealer that had a measurable amount of dead crab in the load. The dealer was instructed the deadloss needed to be weighed and recorded on a fish receiving ticket. The dealer said they understood but when she inspected the fish receiving ticket later, there was no record of the deadloss. The dealer was cited for Failure to Accurately Complete Fish Receiving Ticket.

Seller Fails to Complete Fish Receiving Ticket

A Gold Beach Fish and Wildlife Trooper contacted a limited fish seller who had been selling tuna in September. Investigation revealed the subject had not submitted any fish tickets for the sales. The subject was educated how to properly fill out/submit a fish ticket and was issued a citation for **Fail to Complete Fish Receiving Ticket.**



Undersized Crab Found in Offload - Newport

A Newport Fish and Wildlife Trooper received a call from a wholesale fish dealer that they had started offloading commercial Dungeness crab from a fishing vessel and had noticed several undersized crab. The Trooper arrived and found more undersized crab. The Trooper, with the assistance of a Patrol Trooper, measured the offload and determined that there were 2.9% undersized crab in the load. Both the deckhand and captain were cited for **Unlawful Possession of Undersized Commercial Crab.**

SHELLFISH & ANGLING



Trout Seized - St. Louis Ponds

A Salem Fish and Wildlife Trooper observed anglers at St. Louis Ponds near Gervais following a recent ODFW fish stocking of 125 large brood stock rainbow trout. Anglers are only allowed one trout over 20" per day. A subject was observed catching and retaining two large trout over 25" in length and losing another trout near the bank. The subject was contacted as he was walking towards his vehicle with one of the large trout in hand. The second large trout was located in nearby vegetation and the subject stated he had contacted his brother to come pick up the second large trout. The subject was issued a citation for **Exceeding Daily Limit of Trout** and one trout was seized as evidence.

Woman has Makeshift Fishing Rod but No License

An Ontario Fish and Wildlife Trooper observed a subject actively angling on the shore of Brownlee Reservoir off of Snake River Road. The female subject had a makeshift fishing device which consisted of a plastic water bottle, fishing line, a bobber, hook, and cut fish bait. A records check revealed that she did not have a fishing license. She was issued a violation citation for **No Resident Angling License.**

Trooper Concludes Hatchery Investigation

A Newport Fish and Wildlife Trooper finished an investigation after receiving information from ODFW in September of suspected unlawful activity occurring in one of their fish traps located at the Siletz River Falls. An ODFW employee reported finding a fish measuring board with blood and fish scales on it that they had not used, as well as multiple fishing hooks inside of the trap. Through investigation, it was determined that three subjects had unlawfully entered the ODFW fish trap and taken multiple salmon/steelhead from inside the trap. The three subjects admitted to the offense and indicated they had returned to the same location approximately 3-4 times on various occasions and unlawfully angled for salmon and steelhead in the closed area. An additional fourth subject was found to have angled in the closed area with two of the initial subjects. In addition to the angling case, it was also discovered through one of the subject's phones that he had unlawfully taken a second buck deer during the any legal weapon western Oregon deer season. All four subjects were criminally cited for various offenses including: Take Fish from a Hatchery Facility, Trespass on a Fishway, Angling Closed Area, Take/Possession of Buck Deer, and Exceeding Bag Limit of Game Mammal.

Subjects Exceed Daily Bag Limit of Trout

A Baker City Fish and Wildlife Sergeant contacted a group of three subjects angling at Unity Reservoir. Two of the subjects in the group had over their limit of trout and were continuing to angle. Those two subjects were cited for Exceeding the Daily Bag Limit: Trout and warned for Continuing to Angle After Retaining the Daily Bag Limit. Three trout were seized and donated to charity.

Crabbing Violation - Warrenton Marina

An Astoria Fish and Wildlife Trooper watched an incoming recreational boat as it moored to a slip at the Warrenton Marina. Several minutes prior he also noticed a vehicle arrive and park near one of the marina ramps. He watched as a man from the vehicle walked down the ramp to the boat. Shortly thereafter, three men walked up to the parking lot. One of the men carried an obviously heavy fish bag. A consent search of the bag revealed 31 crab. The men were confronted about only having two people on board. The skipper then admitted he called his friend to meet him at the dock to pick up the extra crab. He was cited for **Exceeding the Daily Bag Limit of Dungeness Crab.** Seven crab were released back into the water.

OREGON STATE MARINE BOARD AWARDS



Troopers from the East Central Team attended the annual Oregon State Marine Board (OSMB) Banquet held in Bend, Oregon. At the banquet, Senior Trooper Brian Jewett received an award for "Oregon State Marine Board Trooper of the Year" for his exceptional efforts in marine board enforcement operations on the John Day River. The East Central Team received an award for "Oregon State Marine Board Program of the Year" for the team's enforcement efforts in boater safety, guide and outfitters regulations and public education and outreach.





Roseburg Senior Trooper Jason Stone was honored at the 2023 Oregon State Marine Board (OSMB) Banquet in Bend as the OSMB Law Enforcement Instructor of the Year. The event was attended by Senior Trooper Stone's friends, family and several members of the Oregon State Police Fish and Wildlife Leadership Team.



North Plains Fish and Wildlife Trooper Ben Turner was honored at the 2023 Oregon State Marine Board Banquet and received an award for "Oregon State Marine Board Trooper of the Year" for exceptional dedication regarding boating safety and education.

CASE DISPOSITIONS



Subjects Plead Guilty in Scappoose Bay Marina Sturgeon Poaching Case

In March of 2022, acting upon a TIP (Turn In Poachers hotline), St. Helens Fish and Wildlife Troopers surveilled anglers moored in a boat at Scappoose Bay Marina for two days. After establishing evidence that angling crimes were being committed, Troopers made contact and interviewed the subjects. A consent search uncovered five unlawfully retained sturgeon. Only one subject admitted to retaining all the fish. He was cited and released For Take/Possession of Oversized White Sturgeon: C Felony, Take/Possession of White Sturgeon x4, No Resident Angling License, and Angling Prohibited Method-Barbed Hooks. Two other subjects were cited and released for No Resident Angling License and No Combined Angling Tag. All the sturgeon were seized and released back into the bay. Two rods/reels and a barbed hook were seized.

On December 13, 2023, the final defendant pleaded guilty and was remanded to custody. The defendants received the following:

Defendant #1 pleaded guilty to Take/Possession of Oversized White Sturgeon: C Felony, Take/Possession of White Sturgeon x4, and No Resident Angling License, and was sentenced to:

- 20 days jail (taken into custody following proceedings)
- 36 months formal probation
- \$5,000 compensatory fine to ODFW
- \$500 to OHA TIP Program
- Three year angling suspension
- · Forfeiture of all seized evidence

The other two defendants took earlier pleas as follows:

Defendant #2 pleaded guilty to **No Resident Angling** License and was sentenced to:

- 10 Days Columbia County Work Crew or 80 Hours of Community Service
- 24 months bench probation
- \$750 compensatory fine to ODFW (suspended upon successful completion of probation)
- Three year angling suspension

Defendant #3 pleaded guilty to **No Resident Angling** License and was sentenced to:

- 24 months bench probation
- \$500 compensatory fine
- Three year angling suspension
