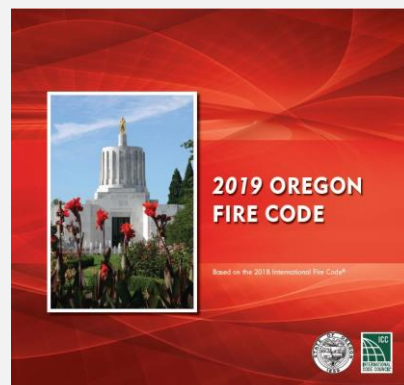

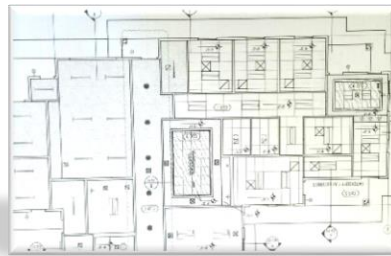
Fire and Life Safety Division Overview

The mission of the Office of State Fire Marshal is "To protect citizens, their property, and the environment from fire and hazardous materials."

The Fire & Life Safety Division is mandated by law to perform duties to enhance fire and life safety for the citizens of Oregon. The Division directs and coordinates fire investigations throughout the state. It is responsible for the development and adoption of the Oregon Fire Code and conducts fire and life safety inspections and healthcare surveys within a variety of occupancies. It also conducts and gives input in new construction plan review.

The division leads the agency's exempt jurisdictions program, by developing and ensuring compliance with exemption rules and is responsible for managing the program's administrative functions.

The Fire and Life Safety Division has twenty-three employees.

Qualifications & Skills

Minimum:

- Five years of full-time fire service experience. This must include two years of full-time code enforcement and one year of fire cause and origin investigation. See posting for additional information.

To comply with OAR 837-039-0110, within six months of employment you must have:

- ICC Fire Inspector II
- ICC Fire Plans Examiner Certificate
