

WORKSHEET FOR USE WITH RELIEF INSTRUCTIONS **Under Oregon Revised Statutes 181.830**

This Worksheet is designed to aid you in determining if you may be **eligible to file a petition in court** for relief under ORS 181.830; however, nothing prohibits you from filing for relief.

NOTE: Providing false information on court documents can lead to perjury charges.
