Police Officer Selection Test (POST) Exam Familiarization



# **Test Format and Helpful Hints**

The POST is made up of four separately timed test sections. The four sections (Mathematics, Reading Comprehension, Grammar, and Report Writing) are made up of story problems, multiple-choice, and true/false formats, and the writing section will assess your ability to write effectively.

Though most of the questions in the POST relate to police duty, no prior knowledge of laws or law enforcement will be needed to answer the questions. It is important to keep in mind the amount of time allowed for each section so you can pace yourself. There is no penalty for guessing, so if you find you are spending too much time on a question, make your best guess and move on.

Be sure to get good quality sleep leading up to the test and to eat and hydrate well the day of the test.



The Math section is first and has 20 questions which you are given 30 minutes to complete. You will not be allowed to use a calculator, so it is very important that you know how to add, subtract, multiply, and divide (including long division) without one, as well as knowing how to calculate fractions and percentages. Be sure to read the problems carefully and fully before answering any of the questions.

The Reading Comprehension section is second and has 25 questions which you are given 25 minutes to complete. Read the paragraphs carefully and fully, noting key phrases and information that might pertain to the questions. When answering the questions, refer back to the paragraph(s) to confirm your answers.

The Grammar section is third and has 20 questions which you are given 15 minutes to complete. This section assesses your spelling ability and your knowledge of correct punctuation and grammar (correct tense of words and prepositions). Consider downloading a grammar study app to prepare for this section.

The Report Writing section is last and has 10 questions. You will be given 15 minutes to complete it. It is important to remember when answering the questions to write in complete sentences and to use the correct information, grammar, and spelling.

## Section II - Reading Comprehension

The Willamette river is enforcing new boating restrictions between Newberg and the Oregon City Falls through the use of stickers. These restrictions apply to all water craft vessels and are effective Monday – Friday only. Vessels with an "1" sticker are considered essential to safety services and may travel and moor (tie up) freely along the river. Guided fishing and sightseeing vessels will be issued a "2" sticker. Delivery vessels will be issued a "3" sticker which allows them access to the river for loading and unloading between 6 and 9 am and 5 to 8 pm only. Business owners along the river will be issued a "4" sticker which allows them access to their place of business. Privately owned vessels with an "5" sticker may be driven and moored along the river on Monday and Tuesday only. Vessels issued a "6" sticker may be driven and moored along the river on Wednesday and Friday only.
