Proposed Rule Amendments

At the August 5, 2022 board meeting the Board voted to propose the following rule amendments. Comments are due by **Oct. 31, 2022 at Noon**. Here is a link to the **Notice**.

Proposed Rule change #1: Remove the (2015) reference as the Code of Ethics was updated by the AOTA in 2020 and is on a 5-year review cycle. The 2020 version has more inclusive language, has been updated to an electronic format and added professional civility items, a new section to the code. The board amendment removes the date altogether and makes a general reference.

339-010-0020 Unprofessional Conduct

- (1) Unprofessional conduct relating to patient/client safety, integrity and welfare includes:
- (h) Failing to follow principles and related standards of conduct as defined in the Occupational Therapy Code of Ethics (2015), by the American Occupational Therapy Association, to the extent they do not conflict with ORS 675.210 through 675.340.

Proposed Rule change #2: Licensees can update their contact information and submit a name change request through the online license portal.

339-010-0018 Name, Address and Telephone Number of Record

(3) Whenever an applicant, licensee or limited permit holder changes their home address, their employer or place of business, their contact telephone number, electronic mail address or their mailing address, they shall notify the Board in writing within 30 days. Written notification may be by regular mail, electronic mail, or facsimile, or through online submission.



Credentials: OTR and COTA

Although you do not need to have a current NBCOT certification to be licensed in Oregon, your employer may require the national certification. You can only use the "R" in OTR if your NBCOT certification is current. Otherwise you must use OT/L meaning you are licensed in Oregon. For an OT Assistant, you can only use the "C" in COTA if you are currently certified. If you are not, you must use OTA/L meaning you are licensed in Oregon.

Filing OTA Supervision with the Board

Any person who is licensed as an occupational therapy assistant may assist in the practice of occupational therapy only under the supervision of a licensed occupational therapist. Before an OTA can start working they must file their OT Supervisor with the board.

OTA's can update their OT Supervisor electronically through the OTLB <u>License Portal</u>. No longer do you have to send in a form. Log in and Click on Supervisor/Supervision Tab, add the name of the OT Supervisor, the Site of Supervision, the Start date and click SAVE. **The OT Supervisor must then log in and change the approval status to "approve".** Once this is done, the OT Supervisor is on file with the board.

OT Board Vacancy: PUBLIC Member

The OT Licensing Board is currently seeking a new **PUBLIC** member to serve on its five member board. A PUBLIC member may <u>not</u> be a spouse, domestic partner, child parent or sibling of an individual who is a licensed occupational therapist or licensed occupational therapy assistant. <u>All board members must be residents of Oregon. ORS 675.310</u>

Board Member Responsibilities: Attend quarterly Board meetings customarily held in February, May, August and November. The meetings begin at 10:00am on the first Friday of the month and generally last until 2:00pm. Sometimes Special Meetings are called in addition to the quarterly meetings.

Review confidential complaints and complaint investigations, including confidential and protected health information regarding members of the public. The Board then determines whether a licensee has violated Oregon statute or rule in the course of their practice, and if so, imposes discipline.

Board members can serve up to 2 four year terms. The new public member will finish out the current term ending on March 31, 2025, under 3 years. Board members are entitled to a stipend of \$151 per board meeting.

The Governor and the Board are committed to ensuring that the Board represents the growing age, racial and gender diversity in Oregon. All citizens are welcome and encouraged to serve.

Self-reporting Requirements

If you are arrested you must notify the Board within **10 working days** of a conviction of a misdemeanor, or an arrest for or conviction of a felony. OAR 339-010-0020 (5)(d).
