

SCAM ALERT!

One of your OT colleagues recently received multiple calls from a scammer who pretended to be from the Board and claimed she had a pending action against her license. The number that appeared on her caller ID was the actual Board number. Fortunately, she called the Board to verify.

The scammer was likely after personal information, or money. If this happens to you the DEA (Drug Enforcement Administration) wants the information to be sent to them: https://www.deadiversion.usdoj.gov/pubs/pressreleases/extortion.com/.

Over the past 3 years, this is the 3rd time the Board has heard from an OT practitioner who was contacted by the scammer.



DEA Warns Public of Extortion Scam by DEA Special Agent Impersonators

The Drug Enforcement Administration is warning the public, including the DEA registrant community, about criminals posing as DEA Special Agents, DEA Investigators, or other law enforcement personnel as part of an international extortion scheme.

The criminals call the victims (who in most cases previously purchased drugs over the internet or by telephone) and identify themselves as DEA agents or law enforcement officials from other agencies. The impersonators inform their victims that purchasing drugs over the internet or by telephone is illegal and that enforcement action will be taken against them unless they pay a fine. In most cases, the impersonators instruct their victims to pay the "fine" via wire transfer to a designated location, usually overseas. If victims refuse to send money, the impersonators often threaten to arrest them or search their property. Some victims who purchased their drugs using a credit card also reported fraudulent use of their credit cards. Another scheme involves criminals contacting doctors and pharmacists and stating that they are the subject of an investigation and demanding money to clear up the matter.

The public should be aware that no DEA agent will ever contact members of the public by telephone to demand money or any other form of payment.

OT Board Vacancy: Public Member

The OT Licensing Board is currently seeking a new **PUBLIC** member to serve on its five member board. A PUBLIC member may <u>not</u> be a spouse, domestic partner, child parent or sibling of an individual who is a licensed occupational therapist or licensed occupational therapy assistant. <u>All board members must be residents of Oregon. ORS 675.310</u>

Board Member Responsibilities: Attend quarterly Board meetings customarily held in February, May, August and November. The meetings begin at 10:00am on the first Friday of the month and generally last until 2:00pm. Sometimes Special Meetings are called in addition to the quarterly meetings.

Review confidential complaints and complaint investigations, including confidential and protected health information regarding members of the public. The Board then determines whether a licensee has violated Oregon statute or rule in the course of their practice, and if so, imposes discipline.

Board members can serve up to 2 four year terms. The new public member will finish out the current term ending on March 31, 2025, just under 3 years. Board members are entitled to a stipend of \$151 per board meeting.

The Governor and the Board are committed to ensuring that the Board represents the growing age, racial and gender diversity in Oregon. All citizens are welcome and encouraged to serve.

Self-reporting Requirements

If you are arrested you must notify the Board within **10 working days** of a conviction of a misdemeanor, or an arrest for or conviction of a felony. OAR 339-010-0020 (5)(d).
