I. Introduction

As OWEB develops the agency's 2025-2027 biennium budget request, staff are seeking the board's feedback. Staff propose to focus on critical agency operations and customer service, enhanced implementation of existing program authorities, and critical needs to build greater landscape resiliency under changing climate conditions. This proposed budget request is in draft form and subject to further changes pending feedback from the Governor's Office and Department of Administrative Services.

II. Budget Preparations for the 2025 Legislative Session

The Oregon Legislature approves budgets for state agencies on a biennial basis. First, each agency submits a requested budget. The Governor then releases a recommended budget, and the Oregon Legislature approves a final budget.

State agencies will submit requested 2025-2027 budgets later this year. Agencies must specifically request additions to the base budget and justify the need for each addition. The requested additions to an agency's base budget are called Policy Option Packages (POPs).

By statute, agencies are also required to submit reduction options of 10 percent. Generally, these are presented in 5% increments.

III. Budget Proposals for the 2025-2027 Biennium

OWEB's proposed 2025-2027 POPs address agency challenges associated with a workload that has increased over time, and that much of this work is being accomplished with limited duration staff. The central objectives in OWEB's proposed POPs are to establish long-term staffing stability to fulfill existing responsibilities,

enhance customer service, enhance implementation of responsibilities as directed by state leaders, and support climate resiliency.

The OWEB proposed 2025-2027 POP list is attached. These POPs have been shared with the Governor's Office and Chief Financial Office at the Department of Administrative Services. The Governor's Office will be providing a response to OWEB's proposed POPs at an earlier stage in the budget process than in the past. This response will be based on prioritizing requests across agencies and economic and revenue forecasts. At the time of writing this staff report, OWEB POPs have not been fully reviewed by the Governor's Office, and there is no certainty that all the proposed POPs will be included in a final Agency Request Budget later this year.

IV. Recommendation and Next Steps for Budget Development

Staff requests board feedback on the attached proposed POP summary. After further engagement with the Governor's Office and external interested parties, staff will bring an updated list of POPs to the July 2024 board meeting.

2025-27 Draft Agency Request Budget Summary

Overview

- OWEB's 2025-27 Overarching Challenges: OWEB's core grant administration workload has grown over time and the agency has also received several new allocated grant programs between 2020 and 2023. One-third of the agency's budgeted positions are limited duration (LD), which is a significant risk to the agency's ability to continue to administer the programs that exist within the agency's portfolio.
- OWEB's 2025-27 Objectives: Enhance OWEB's resiliency and ability to provide customer assistance and support.
 Build capacity to take on additional responsibilities as requested by state leaders. Eliminate or significantly reduce the percentage of LD positions and increase the number of permanent positions to support stability and capacity.
 Enhance OWEB's ability to support climate resiliency through strategic investments in key programs.
- The list below is preliminary and subject to change pending on-going conversations with the Governor's Office and the Department of Administrative Services, Chief Financial Office.
- Italicized text represents policy packages related to the newly established Environmental Restoration Council which
 will oversee the administration of the Environmental Restoration Fund. These funds are not under the purview of
 the OWEB board but are being included here for reference.
