The voluntary actions of Oregonians to improve watershed health are a critical part of the Oregon Plan for Salmon and Watersheds and other conservation efforts.

The Oregon Watershed Restoration Inventory (OWRI), managed by the Oregon Watershed Enhancement Board (OWEB), tracks tabular and spatial information about completed restoration projects, including participants and funding, activities and results. With over 25 years of data collection, OWRI helps tell Oregon's collective progress on fish and wildlife species and habitat recovery and water quality measures.
