



## Mission and Legislation



Core Mission – Accelerate the pace, scale and quality of forest restoration to increase the resilience of Oregon's federal forests.

Guiding State Legislation ORS 526.275— "...a policy of the state to pursue projects under the [GNA] that

- increase timber harvest volume,
- contribute to job creation,
- reduce wildfire risks to all lands,
- improve wildlife habitat and watershed health and
- stimulate local economies."



- Goal: increase the number, acreage and complexity of collaboratively planned projects in Oregon.

- Administered in partnership with OWEB

#### FOREST COLLABORATIVE GRANT INVESTMENTS





- \$5,872,467 invested in supporting forest collaboratives
- \$39,226,017 invested in FFRP overall





## Changes for 2025-27 offering

- 5% match, up from \$1
- An additional question related to similar investments in the forest collaborative or applicant geography
- Added climate related questions
- For ZOA applications, requesting discussion of existing or potential areas of disagreement and strategies to resolve them
- Certain documents are required to be uploaded as part of the application



### Required Uploads

- At least one color map
- Formal Organizational Structure Documentation
- Proof of Engagement with USFS and BLM
- Meeting Minutes
- USFS and/or BLM Letter of Support








### Optional Uploads

- Federally Negotiated Indirect Cost Rate (FNICR) agreement
- Other
  - Uploads that further the explanation of the problem statement and proposed solution
- Secured Match Forms
