



HB 3342	Electronic documentation
HB 3544	<ul style="list-style-type: none">• Uniform (protests, requests for party status, contested cases)• Automatic final orders (33 days)• Default hearing schedule (180 days)• Oral testimony• Remote hearings

Division 2 – Protests & Contested Cases

Process/Policy	
Add	Consolidation/bifurcation of hearing(s) prior to referral
Add	Discovery limits, including admissions, interrogatories, staff time, subpoena deadlines, site visits
Add	Accurate contact information
Add	Default to electronic service upon referral
Add	List of items for pre-referral to encourage settlement (Limited)
Clarify	Information included with exceptions
Housekeeping	
Clarify	Interface with Administrative Procedures Act (APA)

Add	Pump test submission with claims of beneficial use
Align	Standardized mapping criteria (Div 305) with supplemental
Clarify	Rule applicability

Division 300 – Definitions

2025 Legislation	
HB 3544	Align definitions with statute and across rule divisions (protest, contested case, etc.)
Housekeeping	
Add	Applicability to Div 380 (Water Right Transfers); Div 385 (District Water Right Transfers)
Remove (Unused or Expired)	“Planned Uses”, “Water is Available”
Clarify	“Proposed Certificate”, “Stockwater Use”
Align	“Water right subject to transfer” to “Water use subject to transfer”

Division 310 – Water Right Application Processing

2025 Legislation	
HB 3342	<ul style="list-style-type: none">• Electronic documentation• Phased processing, fee payment
HB 3544	<ul style="list-style-type: none">• Uniform (protests, requests for party status, contested cases)• Automatic final orders (33 days)
SB 1154	Groundwater Quality Management Areas – allow issuance of groundwater permit if certain exempt wells consolidated (drinking)

Division 310 – Water Right Application Processing

Process/Policy	
Require	Notice to landowner if someone applies for water right on their property
Require	Proof of signatory authority
Remove	Required information already available to OWRD
Clarify	Administrative holds
Remove	For some, posting OWRD weekly public notice
Align	Standardized mapping criteria (Div 305) with supplemental
Housekeeping	
Align	Div 5 (land use compatibility); remove ability to accept land use receipts and to approve without land use information
Clarify	APA notice requirements
Remove	Authorities no longer in statute

Division 315 – Water Right Permit Extensions

2025 Legislation	
HB 3342	<ul style="list-style-type: none">• Extension allowances• Electronic documentation
HB 3544	<ul style="list-style-type: none">• Uniform (protests, requests for party status, contested cases)• Automatic final orders (33 days)
Process/Policy	
Remove	Checkpoint conditions
Clarify	Proposed final order on extension may initiate cancellation
Align	Policy requiring compliance with fish-related permit conditions
Housekeeping	
Align	Storage project extensions for counties, municipalities, and districts with internal guidance and statute
Align	“undeveloped portion” definition, reference to federal statutes

Division 340 – Water Use Authorizations

2025 Legislation	
HB 3342	Electronic documentation
Process/Policy	
Clarify	When a public comment has raised a public interest issue that merits the standard process
Align	Standardized mapping criteria (Div 305) with supplemental
Housekeeping	
Remove	Circular rules references
Align	Limited licenses with statutory language

Division 77- Instream Water Rights

Recent Legislation	
HB 3164 (2023)	Split season leases permanent authority
HB 3342	<ul style="list-style-type: none">• Electronic documentation• Phased application processing• Applications returned for sources closed to further appropriation
HB 3544	<ul style="list-style-type: none">• Uniform protests, requests for party status, contested cases• Automatic final orders (33 days)• Orders issued without hearing that modify proposed final orders• Standardize terminology

Division 77 – Instream Water Rights

Process/Policy	
Clarify	When withdrawal applies to new instream water right applications
Remove	Forfeiture of instream water rights
Clarify	Allowed timelines for administrative holds
Align	“enlargement” and “injury” determination
Remove	Requirements to post notice in certain offices
Housekeeping	
Remove	“estimated annual natural flow” for limits on transfers, leases, and allocations of conserved water
Align	“minimum perennial streamflow” conversion
Align	APA – mailing of notices
Clarify	Measuring, reporting

Division 77 – Instream Water Rights

Process/Policy	
Clarify	Instream water rights issued within Oregon's borders
Clarify	Rights that can be transferred, including storage rights
Align, Add, Update and Remove	Various definitions

Division 77 – Instream Water Rights

Instream Leases	
Add	District – keep written authorization on file; Streamline lease renewals
Clarify	Storage rights lease requirements
Add	Federal Gov't Consent – keep copies of contracts
Remove	Watermaster office - post lease application notice
Precedence of Future Uses	
Align	With statute and follow water right processing, including public comment instead of hearing, incorporate into proposed final order

Process/Policy	
Align	Initial review step consistent with other processes
Align	Standardized mapping criteria (Div 305) with supplemental
Clarify	Application Requirements
Housekeeping	
Align	Does not require completion date be unexpired, per statute
Align	Mailing notice with APA
Clarify	To align with other rules and statute, including injury applicability

Division 18 – Allocation of Conserved Water

Legislation	
HB 3342	<ul style="list-style-type: none">• Electronic documentation• Weekly notice• Phased application processing, public comment timing
HB 3544	<ul style="list-style-type: none">• Uniform (protests, requests for party status, contested cases)• Automatic final orders (33 days)
Policy/Process	
Align	With other processes, including same source criteria for injury
Clarify	Measuring, reporting requirements
Align	Standardized mapping criteria (Div 305) with supplemental
Housekeeping	
Clarify	Steps for approval, completion, testing phase, and finalization

Division 380 – Water Right Transfers

Legislation	
HB 3342	<ul style="list-style-type: none">• Electronic documentation• Weekly public notice• Phased application processing
HB 3544	<ul style="list-style-type: none">• Uniform (protests, requests for party status, contested cases)• Automatic final orders (33 days)• Standardize terminology

Division 380 – Water Right Transfers

Process/Policy	
Add	Conditioning - to prevent injury and enlargement
Add	Temporary Transfers – renewals
Add	Transfer Permit Amendments – new rules
Modify	Clarification of Water Rights- Director to consider exceptions to Administrative Law Judge's proposed order instead of Commission
Align	Standardized mapping criteria (Div 305) with supplemental

Division 380 – Water Right Transfers

Process/Policy	
Clarify	Reversion Request - transfer holder/receiving landowner notifies OWRD that POD/POA change is incomplete
Clarify/ Align	POU changes - require physical change altering where water right is located
Clarify	Interface with Forfeiture - process when forfeiture raised as part of transfer protest (see also Division 17)
Clarify	Specific-to-General Industrial Use – information re: quantity of water diverted for original industrial use
Add/ Clarify	Application information to assist with evaluation of fish screens and passage, evidence of use and ownership

Division 380 – Water Right Transfers

Changes in Point of Diversion (POD) to Reflect Historical Use

Align	Applicant to provide proof of notification
Clarify	Criteria for approval, including enlargement
Clarify	Applies to surface water, not groundwater
Clarify	Does not apply to changing dam location
Clarify	Claim of injury process and other provisions

Housekeeping

Align	Similar to division 310
Remove	Redundant definitions
Remove	Temporary Transfers – character of use to store water
Clarify	Layering - notify applicant and how to resolve; Consent to Injury
Require	Substitution – must terminate prior to making change

Division 382 – Groundwater Registration Modifications


Consistency with Legislation	
HB 2803	Increases max fees; Rule language to align
HB 3342	<ul style="list-style-type: none">• Electronic documentation• Weekly public notice
HB 3544	<ul style="list-style-type: none">• Uniform protests, requests for party status, contested cases• Automatic final orders (33 days)• Standardize terminology
Process/Policy & Housekeeping	
Align	Standardized mapping criteria (Div 305) with supplemental
Clarify	Layering - notify applicant of layering issues and how to resolve
Remove	Redundant definitions
Align	“tentative priority date” and “certificate of registration” definitions

Division 17 – Cancellation of Perfected Water Rights

Legislation	
HB 3544	<ul style="list-style-type: none">• Uniform (protests, requests for party status, contested cases)• Automatic final orders (33 days)
Process/Policy	
Modify	Director to consider exceptions and issue final order
Clarify	Process when forfeiture raised as part of transfer protest
Align	Information watermaster can use for 5 years of affidavits process
Remove	Rules-only requirement for OWRD staff to submit affidavits
Clarify	Information required in OWRD notices, public affidavits, used
Housekeeping	
Align	Process for initiation of cancellation
Align	Exceptions related to “ready/ willing/ able” and drought
Align	Reasons for rebuttals to forfeiture
