Need & Background



Rulemaking Background & Need

2025 Legislative Session

OREGON

- Expectations from legislature and governor
- House Bill 3544 contested case processes
- House Bill 3342 water right transactions
- Policy & process improvements for impacted rule divisions
- Minor (grammar, spelling, statutory references, etc.)
- Outdated rules that do not conform to statute; other recent legislation
- Creating consistent processes where possible

House Bill 3544

- Uniform Processes
- Standardized Schedule and Timelines
- Oral Testimony
- Efficient Final Orders
- Settlement Opportunities

- Accessible Hearing Locations
- Streamlined Standing and Intervention
- Consistent protest and party status requirements



House Bill 3342

- Electronic documentation
- Shift public notice to OWRD weekly notice
- Credit/debit card processing
- Withdrawal of waters from appropriation technical fix
- Efficient review where water is

restricted

- Phased application processing and fee payment
- Limits on extensions



Rulemaking Scope

- Applications for
 - new water rights
 - changes to existing water rights
 - extensions on timelines to develop water right permits
 - protecting water instream (e.g., leasing, transfers, conserved water, new water rights)
 - others
- Hydroelectric processes (limited scope; mostly contested case)
- Forfeiture & cancellation
- Contested Cases / Protests
- Mapping standardization
