1. Yes, our primary water right is KA 136 / POD 2 / May 25, 1908.
2. The answer to question 1 is correct. Our land is also permitted under 40926 (Certif. # 48029) in 1976.
3. POD 2 is the correct location at approximately 42° 21'20.81 / 121° 48'25.75
4. The physical nature of POD is via pump and irrigation ditch.
