Introduction

Oregon's juvenile justice system is committed to providing effective and efficient services to promote public safety, ensure justice for victims, and prevent youth from repeating criminal behavior. This document contains statewide and county specific data describing offenses committed by juveniles and the characteristics of the juveniles committing those offenses in the State of Oregon for each reporting year.

Contents of this report

There are two sets of data for each jurisdiction, "Youth" counts and "Referral" counts. Additionally, there are statewide data sets for youth and referrals. The data counts:

- the number of unique youth processed by the juvenile justice system in the reporting year. This means no matter how many times a youth is referred, the youth is only counted once in the youth data. The youth is categorized by the most serious offense the youth committed during the reporting period and is included in the county that received the most serious offense.
- the number of unique referrals received by county juvenile departments during the reporting year. A single youth can have more than one referral in a year (i.e., the youth may have several reports by the police). The most serious charge associated with a referral is used to categorize the referral.

The report divides the counts into criminal offenses (felony and misdemeanor), non-criminal offenses (violations), and dependency/status offenses (runaway). Each category is further divided into sub-categories based on crime types.

Starting with the 2023 reporting year, felony and misdemeanor offenses are reported separately within the criminal offense category. Sub-totals and grand totals are provided for each category.

Each statistic is broken down by sex, age at time of referral, and race/ethnicity of the youth.

Appendix A contains the specific mappings between the Oregon Revised Statute (ORS) offense numbers and the reporting categories used in this report.

Appendix B is a chart of the severity scores for each crime category's class and type, which is used to determine the seriousness of the crime.

Notes about the information

Counts: The youth count is a count of unique youth who had referrals during the year throughout the state. A youth could be referred by more than one county. However, the youth is counted only once on the statewide report for their most serious offense and reported in the county that handled that offense.

Referrals Included: The date the juvenile was referred to the juvenile department ("Referral Date") was used to select data for inclusion in this report.

Categories: These reports categorize offenses according to ORS, Criminal Code of Oregon, as defined by the Oregon Legislature. Please note the ORS categories sometimes differ from the Oregon Uniform Crime Reporting (OUCR) categories. Consequently, the categories and counts may differ from OUCR statistics.

- OUCR categorizes offenses that are neither person nor property as “Behavioral”. ORS does not categorize offenses as “Behavioral”. However, “Behavioral” offenses can be inferred on these reports. Any offense outside the person or property category is comparable to the OUCR “Behavioral” category.
- Local ordinances are not included on the reports.
- Inchoate crimes (incomplete crimes such as attempts, solicitations, and conspiracies) are reported in the crime category for the crime with which the inchoate is associated (e.g., Attempted Murder is reported in the Homicide-related offense category). Inchoate crimes that result in a violation classification are reported as non-criminal.

County: Referrals were assigned to the county responsible for handling the referral, as indicated by the county of the worker who originally entered the referral in JJIS (Referral Original Worker County).

Dependency Status Offenses: Most status offenses are included in the Non-Criminal reporting category. However, a few status offenses are categorized in statute as Dependency. These include Runaway, Beyond Parental Control, and Behavior to Endanger Self or Others. Not all counties enter Dependency status offenses.

Demographics: The JJIS Steering Committee recognizes that reporting race, ethnicity, sex, and gender in JJIS may not accurately represent everyone, due in part to a need to comply with federal reporting requirements. We respect all individuals, but also acknowledge that we cannot capture how individuals may self-identify in these areas.

- **Race and Ethnicity:** The JJIS Steering Committee defines Race/Ethnicity reporting categories based on available data. Race is recorded by the juvenile department based on police reports and youths’ self-reporting. These reports categorize youth by the race that is recorded in JJIS unless the recorded ethnicity is Hispanic. When the recorded ethnicity is Hispanic, the youth is categorized as Hispanic, regardless of race.
- **Sex:** The options for reporting sex currently include Male, Female, or Unknown. There are current state and national discussions about new ways to document sex that are respectful and inclusive of all. The JJIS Steering Committee will continue to engage in those discussions and make updates in this area as available.

Cautions regarding youth and referral data

Comparison to Juvenile Recidivism

“Total Referrals” in this series of reports count criminal and non-criminal referrals received during the calendar year. Oregon’s Referral-Based Recidivism Report (12- or 36-Month versions) counts only criminal referrals and subsequent criminal referrals for a youth. Consequently, the numbers of referrals in the two reports are not comparable.
