In order to obtain official education records for youth who attended or participated in school while in an Oregon Youth Authority correctional facility, please contact the Oregon Department of Education or the school attended directly. The Oregon Youth Authority does not have official school records. The Oregon Youth Authority has vocational records and may have limited information about educational progress should a youth be required to attend school.
