Update on query progress – The below numbers represent a snap shot of data captured as of 6/14/2016. This data will continue to change as PERS staff regularly review and make corrections to accounts on a daily basis.

- Identified 19,910 members whose account can be fixed via .dat files. That leaves 35,167 members whose accounts need to go through an eligibility review and manual corrections.
- It is assumed that the 1,277 closed accounts do not have any eligibility issues. These closed accounts require additional processes that prevent the .dat file fix. These accounts must be re-opened and adjustments need to be coordinated with a third party vendor.

* Each PERS ID may have more than one salary transaction. Some exclusions are record specific, thus the Excluded population also covers members on the Included list for issues such as zero \$ Gross Salary. The Included, Closed and Excluded numbers will not add up to the count of Unique IDs as a result.

Criteria for Exclusion:

- Potential Non-Members: have never reached 600 hours AND have no contributions posted on account.
- Needs Eligibility Review:
 - Exist in the uncompleted Qualifying/Non-Qualifying population need individual account review because Q/NQ may not be an issue in the year of the CSD, or any other years
 - Deceased members
- Transaction codes don't match membership status, e.g. waiting time wages after CSD or regular wages before CSD, or retiree wages posted to an active membership.

- Wages 30+ days after CSD transactions with pay dates more than 30 days from the CSD
 need individual account review to identify reasons why wages after the first full pay period
 were submitted without contributions and if there were any other eligibility issues
 involved.
- \$0.00 Gross Salary Total Gross Salary reported as \$0 in the original DTL2 record.
- Salary is \$0.01 in Subject Salary The \$0.01 is often used by PERS staff to correct accounts with specific system issues.
- Negative Adjustments These records complicate the data and prevent us from using a query to determine which wage should be corrected.
- Foreign National OPSRP members are entitled to service credit but not contributions.

<u>Issues that cannot be queried or query cannot validate:</u>

- Year has over 600 or more hours but 6 month wait time requirements are not met:
 - o Missing wages during the 6 months wait time
 - o CSD doesn't match Start Date of a qualifying position
 - 30 working day break(s)
 - Term Date is before end of 6 month wait time, jClarety may not correctly reset the CSD
 - ➤ Incorrect CSD would impact the validity of an invoice
- Multiple memberships and potential Qualifying/Non-Qualifying issues.
- Previous corrections to existing transactions are not captured correctly. Sometimes the adjustments are pulled into the query but not the originals and vice versa which makes it impossible to tell if the account should be included just based on the query data.
- Moving target CSD changes and other corrections are made on a daily basis to a large number of these accounts. From the time the query is pulled until the actual .dat file, many of these accounts should no longer be fixed, thus causing issues for the .dat file process.

Discussion:

Based on the above data, PERS can proceed to calculate the financial impact for each of the EAG members. It will then be up to the EAG to develop a request to present to the Board for consideration.
