NEED FOR THE RULE(S):

Temporarily adopts revised protocol versions for standard vaccine protocols to align with the most current Centers for Disease Control (CDC) Advisory Committee on Immunization Practices (ACIP) recommendations.

JUSTIFICATION OF TEMPORARY FILING:

Failure to amend vaccine protocols in OAR 855-115-0345 to align with CDC ACIP recommendations may result in compromised patient access and care, posing a significant risk to public health by leaving individuals vulnerable to preventable diseases and potentially overwhelming other healthcare providers.
