To implement the notice requirements that for rulemaking under 183335 and also adopting the Oregon Attorney General's model, rules of administrative procedure, the second purpose is to formally adopt rules of policy and procedure governing the provision of facilitated dispute resolution services.

Now, practically what that means is that First off are the office of the public record advocates statutory obligations, and what our authority extends to. That's pretty that's well defined in statute.

The purpose of these rules is does just to provide a little bit more contour and shape. To a particular form of service that our office can provide, which is.

This kind of formal, facilitated dispute resolution service. The purpose of these rules again formalizes the processes and procedures governing delivery of facilitated dispute resolution services. Of note, these rules do not affect the current and ongoing delivery of the sort of informal mediation between records requesters and public B.

That we have been doing since the inception of the office.

Our statutory authority is identified.

ORS 192468 and ORS 192464.

OK, at this time following that brief introduction, I'm going to go ahead and open the public hearing.
