An administrative meeting of the Psychiatric Security Review Board was convened on

June 22, 2017 at 10:00 a.m. in the fourth floor conference room of 610 SW Alder Street,

PSRB staff present in person included Juliet Britton, J.D., Executive Director; Sid Moore,

Deputy Director; and Jane Bigler, Executive Secretary, as note taker. Also present was Harris

Matarazzo, Attorney at Law; new adult panel attorney member Anne Nichol, J.D.; and, from

Pacific University's School of Graduate Psychology, Leonardo Bobadilla, Ph.D., Allison

Foerschner, MA, and Lyssi Brady, who are here to conduct a presentation on Restorative Justice.

At 10:04 a.m., the Board's Executive Director, Ms. Britton, indicated that the time for

public comments would be moved to the end of the meeting. Ms. Britton then asked the adult

panel to review the minutes from March 22, 2017. Ms. Lieber moved to accept the minutes as

written and Mr. Swetnam seconded the motion. The motion passed unanimously. Ms. Britton

then asked the juvenile panel to review the minutes from December 12, 2016. Dr. Miller moved

to accept the minutes as written and Ms. Kuenzi seconded the motion. Dr. Garner abstained as he

was not yet a Board member at the time of the previous meeting. The motion passed

unanimously with the remaining members.

Next, Ms. Britton introduced the individuals present from Pacific University and they

proceeded with their presentation on Restorative Justice.

After the presentation from Pacific University, Mr. Moore proceeded with an update on

repealing OAR 859-020-0020 and the language fix proposed for OAR 859-200-0020(9), wherein

the Board members would delegate the task of administrative oversight to the Deputy Director

position. Ms. Lieber moved to accept this change and Dr. Balduzzi seconded the motion. The

motion passed unanimously.

Ms. Britton then provided a Legislative Update regarding the disassembly of the State

Hospital Review Panel (SHRP): more specifically, the jurisdiction of all Tier 2 clients currently

under SHRP will transfer to PSRB. However, this legislative change will not be implemented

until July 1, 2018. Ms. Britton indicated that the Board might see a slight increase in the number

of inpatient hearings. Mr. Moore will reach out to the Oregon Judicial Department regarding

training.

Discussion then continued regarding the next steps associated with Restorative Justice.

Board members will form a workgroup. Mr. Swetnam, Ms. Elmer and Ms. Nichol expressed

interest in being a part of the workgroup.

Ms. Britton then asked if there were any public comments and there were none.

The next adult panel meeting will be held on September 20, 2017 at 10:00 a.m. and the

next Juvenile Panel meeting is scheduled for December 8, 2017 at 10:00 a.m.

The meeting then moved to Executive Session and guests were excused.
