

## Attending a PSRB Hearing in Salem (@ the Oregon State Hospital)

Typically PSRB hearings are held at the Oregon State Hospital in Salem which is located at:

**2600 Center Street NE, Salem, OR 97301** *{driving directions on page 2}*

**Parking:** *{See detailed map of OSH on page 3}*

When you turn off of Center Street you will see a long row of spots to your left (along Recovery Lane). These spots are labeled **“Museum/Visitor Parking”** and these are likely your best bet for parking. There is another very small parking lot with a few spaces if you continue down Recovery Lane about ¼ mile (labeled **“Court Parking”**—to your right).

PSRB hearings are held in **the Kirkbride building**, which is a dark red building located at the top of the hill with a roundabout in front (to the right of the flagpoles). Once you arrive, you will have to sign in at the **“Comm Center”** (front desk).

Be sure to bring your ID and inform the folks at the desk that you are here for a PSRB hearing. They will screen you in the lobby and someone from security will bring you back to the hearings room. **Please note that OSH is a secure facility and thus there may be certain items you are unable to bring in to the hearings room.** However, OSH does provide lockers for safekeeping in the event you have an item that cannot be brought into the hearing room. Depending on the docket day and where we are in the schedule, security may take you directly into the hearings room or take you to a conference room to await the hearing.



## Driving Directions -


*NOTE: Please use your own GPS to plan your trip. Below are the basic directions to get to OSH from i5.*

From the North (i5 Southbound): Take Exit 256



- > Follow I-5 S to Market St NE in Salem. Take exit 256 from I-5 S  
43 min (44.8 mi)
- < Follow Hawthorne Ave NE to Center St NE  
4 min (1.4 mi)
- ▲ Merge onto Market St NE  
407 ft
- ↩ Use the left 2 lanes to turn left onto Hawthorne Ave NE  
0.7 mi
- ↪ Turn right onto Center St NE  
0.6 mi  
Destination will be on the left

From the South (i5 South): Take Exit 256



- > Follow I-5 N to OR-213 S/Market St NE in Salem. Take exit 256 from I-5 N  
58 min (63.8 mi)
- < Follow Hawthorne Ave NE to Center St NE  
4 min (1.4 mi)
- ↩ Use any lane to turn left onto OR-213 S/Market St NE  
Continue to follow Market St NE  
0.1 mi
- ↩ Use the left 2 lanes to turn left onto Hawthorne Ave NE  
0.7 mi
- ↪ Turn right onto Center St NE  
0.6 mi  
Destination will be on the left

If coming from I5 South bound  
it is Exit 256
