TITLE/SUBJECT: OSH Conditional Release Process Post-PSRB Hearing

APPLICATION: OSH, Community Providers

EFFECTIVE DATE: January 15, 2025

POLICY

This policy aims to facilitate a smooth and expedient transition for clients moving from the Oregon State Hospital (OSH) to a designated Community Provider following their conditional release by the Psychiatric Security Review Board (PSRB). Effective planning and clear communication are critical to this process, requiring coordinated efforts between the PSRB, OSH staff, and Community Providers. Given the specific steps following a PSRB hearing may vary depending on placement vacancies and any additional contingencies outlined in the PSRB's conditional release orders, this standardized process guarantees that all required steps are completed efficiently, documented thoroughly, and communicated effectively to support each client's prompt conditional release to the community.

PROCEDURES

Conditional Release is Contingent Upon Maintaining Psychiatric Stability

When the PSRB grants a conditional release at a hearing, the release order will specify that the client's release is contingent upon maintaining psychiatric stability. Although rare, if there is a significant change in the client's psychiatric condition or other factors affecting their ability to be safely managed under the approved conditional release plan arise prior to the conditional release, the PSRB's order requires OSH and Community Providers to promptly notify the PSRB of these changes. They are also encouraged to provide any additional recommendations, which may include modifying the approved plan or requesting that the conditional release be rescinded. These requests are carefully reviewed and assessed by the PSRB's Executive Director (ED), who will determine the appropriate course of action.

Scenario 1: Conditional Release Within 60 Days of the PSRB Hearing

When the conditional release date is within 60 days of the hearing, the following steps are taken:

- ✓ The PSRB will email the OSH Liasian a Summary of Findings signed by the PSRB's Executive Director (ED), authorizing the conditional release.¹
- ✓ The Community Provider must promptly email the PSRB (<u>psrb@psrb.oregon.gov</u>) upon the client's discharge from OSH and admission to their program.
- ✓ The OSH social worker or designee will submit to FileCloud a current photo of the client and the OSH Discharge Summary as soon as practicable.²
- ✓ The PSRB will distribute the official Conditional Release Order within 30 days of the hearing.

¹ The Summary of Findings authorizes the conditional release of an client from the Oregon State Hospital, based on the PSRB's decision at a hearing, before the PSRB's order is officially finalized and signed.

Scenario 2: Conditional Release More Than 60 After the PSRB Hearing

When the conditional release is expected to occur more than 60 days after the hearing, the following steps are taken:

- ✓ Within 30 days of the hearing, the PSRB will distribute a Conditional Release Order outlining contingencies that must be met before release, pending review by the PSRB ED.
- ✓ Both OSH and the Community Provider must carefully review the order to ensure compliance, as it serves as a placeholder until all contingencies are met before the conditional release occurs.
- ✓ Prior to conditional release, the following must be completed:
 - ➤ An updated consultation between the OSH and the Community Provider's Licensed Medical Practitioners (LMP), with the Community Provider's LMP completing the PSRB's form attesting to this consultation.³
 - Written confirmation from the OSH LMP or designee that the client remains psychiatrically stable and appropriate for conditional release. This confirmation should be documented in formal OSH records (not via email).
 - ✓ The Conditional Release Order will also require OSH to submit written documentation to both the PSRB and the prospective Community Provider if there are significant changes to the client's psychiatric stability, medication regimen, or any other relevant incidents following the hearing.⁴
 - ✓ For timely processing, all documentation must be submitted to FileCloud⁵ at least 48 hours prior to the anticipated discharge date for final review and approval by the PSRB ED. As specified in the order, conditional release should not occur until confirmation of approval from the Executive Director is received.

PSRB's Commitment to Timely Conditional Release
