## General Special Conditions

- Client shall have no cell phone contract, credit card or bank account without approval of case manager
- Client shall not engage in the borrowing, lending, selling or trading of items or money without prior written permission from case manager
- Client shall not purchase items, or accept items for free from peers without prior written permission from case manager
- Client shall participate in a treatment program coordinated by the staff of his/her treatment facility
- Client shall abide by all rules, regulations and requirements established by the staff of his/her treatment facility
- Client shall participate in a medication regimen as established by the treating physician at his/her treatment facility
- Client shall meet with his/her medication prescriber at a determined time for medication review
- Client shall meet with his/her case manager at a minimum of 2 times per day
- Client shall designate a payee for all of his/her funds as directed by her case manager
- Client shall participate in a money management program as directed by his/her case manager
- Client shall have no contact with the victim(s) of the instant offense
- Client shall comply with the specific conditions of her release contained in this order as well as the Board's general conditions of release contained in its form

## Arson Special Conditions

*Note: Clients with a history of arson should have a condition regarding access to incendiary devices*

- o Client shall not carry or have in his/her possession any matches, lighters or other incendiary devices. If he/she owns such a device for the purpose of smoking, it shall be kept by staff and operated only by staff. Shall not smoke except with direct, constant supervision by staff.

## Communication Device Restrictions

*Note: Clients with sex offense history, stalking, or victim contact concerns may warrant these conditions*

### Internet Usage:

- Client shall not access the internet by telephone, computer or any other electronic communication device without having a staff member simultaneously watch the screen the entire time patient accesses the internet.
- Client shall not access the internet without having a staff member simultaneously watch the screen the entire time patient accesses the internet.
- Staff shall directly monitor the screen at any time patient accesses the internet.
- Staff shall simultaneously watch the screen at any time patient accesses the internet.
- No contact, direct or through a third party, in any form, with any family

### Additional Computer Restriction Examples

- Client shall not use a computer or other device that has internet access except a "house computer," in a common area of the residence
- Shall not use any computer except for purposes designated by her case manager and in locations designated by her case manager. Staff shall monitor the browser history of any computer she uses on a weekly basis
- Client shall not watch any media with a horror or violent theme

### General Cell Phone Restrictions

- Client shall not purchase nor utilize a disposable or pre-paid cellular phone
- If client wishes to own a cell phone, he/she must contract with a provider that supplies a list of all calls and texts made from the phone on monthly basis; client shall provide his/her case manager with a copy of that log as soon as it is available each month. Client 's case manager shall review that list each month to assure has not attempted to contact prohibited persons

## Coordination of Care Special Condition

- o Client and client's case manager will work together to ensure that Client completes a Release of Information for other providers (Examples: VA hospital, OHSU, Indo-Chinese Clinic, Department of Corrections).
- o Case manager shall have at least one contact per month with client's primary doctor to ensure medical care is coordinated with mental health treatment.
- o [This helps all of those providing services to Client know what Client's needs are, know what is already being provided and determine the appropriate treatment plan and services based on assessment, needs and the most comprehensive information available ].

## Driving Special Conditions

- Client may drive
- Client may operate a vehicle for employment and treatment purposes only.
- Client may drive solely for purposes of employment and treatment activities
- Client may drive for limited purposes as specified by his case manager
- Case manager may authorize driving within Multnomah, Clackamas and Washington Counties for the sole purpose of visiting family members. He/she must obtain specific permission for each trip.
- Client may drive to and from work and operate a company-owned vehicle.
- Client may drive for purposes of employment and treatment only - no shopping or other errands, no social outings
- Client may drive; no passengers without case manager's prior approval; May travel outside Tri-County area, incl. driving, with cm approval;
- Client may drive within the Eugene-Springfield area only, solely for work- and treatment-related activities. May not drive for errands, social activities or other purposes.
- Client may drive for employment, medical and treatment-related appointments, and other purposes designated by case manager. Other restrictions as noted by case manager
- Client may drive for purposes designated by case manager, between hours of 8:00 am and 8:00 pm
- Client may pursue obtaining a driver's license. When that has been obtained, client's case manager shall submit a request for driving privileges to the Board.
- Client may drive for purposes designated by case manager
- Client may drive only for purposes of obtaining his driver's license. Must attend a driving instruction course and client shall only drive during the course and during the driver's license test. When the driver's license has been obtained, case manager may submit a request for driving privileges to the Board.

## **Intimacy Special Conditions**

- Client shall disclose criminal history to any person with whom he/she intends to become intimate with. Disclosure is to be verified by case manager
- Case manager shall meet with the person and consider whether couples counseling would be appropriate.

## Medical Change Special Conditions

- o Client's licensed medical provider shall not initiate any non-emergency major psychotropic medication change without prior notice to the Board for purposes of consultation regarding the appropriate level of residential care for the client during the course of the proposed change.



### **Medical Diagnosis/Condition Special Condition**

- Client shall comply with special, specific directions and instructions given by his/her medical provider as a result of a specific medical condition or diagnosis.
- (Example: Mr. X's doctor has ordered that Mr. X, as a result of his medical diagnosis, have dietary restrictions and that specific rules be followed regarding eating. Mr. X is a diabetic and his sugar intake must be closely monitored and insulin level regularly tested.)

## Payee Special Conditions

- Client shall designate a payee for all of her funds as directed by his/her case manager
- Client shall not obtain a credit card, bank account, or enter into a contractual obligation without prior written permission from case manager

## Post-Prison Supervision or Probation Conditions

- o Client must abide by all post-prison supervision or probation conditions

### **Relapse Prevention Conditions**

- May not associate with any known drug user or person specifically identified by case manager as a negative influence due to prior substance abuse
- Shall not associate with any person who is actively using alcohol or illicit drugs
- Shall not possess paraphernalia related to alcohol or illicit drug use

## Restraining Order/Stalking Special Conditions

- Shall not have contact, in any form, with the protected person in Stalking Protective Order No. [xxx] issued in [county]
- Might also include: or any member of his/her family

### **Sex Offender Special Conditions**

- Maintain current sex offender registration with the Oregon State Police
- Shall not go to any location where minors are likely to be present, such as fast food restaurants, schools, amusement attractions, day care centers, community swimming pools, and play areas of parks
- Must promptly report any inadvertent contact with a minor to residential staff and case manager
- Shall not be present at places where minors are likely to congregate, except as necessary in the course of taking public transportation to authorized activities
- Shall be supervised at all times he is present in a location likely to be frequented by minors
- May not be present without a supervisor designated by his case manager at any location where minors are likely to congregate, such as a playground, school or fast food restaurant
- Shall have no contact with minors other than brief, incidental contact that may occur in public. Shall report any such contact to his case manager.
- Shall be supervised by an individual designated by case manager at any time it is anticipated that he may be in the presence of a minor (eg. fast food)
- Shall not go to any location designated for minors, as defined by his case manager, including, but not limited to, K-12 schools, amusement attractions or play areas of parks
- Client shall not possess, obtain or view pornographic materials

## Supervision Special Conditions

### Initial Supervision Level:

- Client shall be supervised staff, within 20 feet and within line of sight, at all times he/she is outside of the secure perimeter of the facility

### Short Peer Passes:

- Shall be supervised by staff at any time he is away from the residence, except as follows: The conditional release supervisor or case manager may authorize one Short Peer Pass per day as outlined in policy
- The resident shall carry a GPS tracking device that is reviewed upon the resident's return to the facility
- Staff shall conduct random community checks and random drug and alcohol screens upon return from pass

### Short Passes with an Approved Other:

- Shall be supervised by staff at any time he is away from the residence, unless case manager may authorizes Short Peer Passes and Short Passes with an Approved Other as described in pass policy
- The resident shall carry a GPS tracking device that is reviewed upon the resident's return to the facility
- Staff shall conduct random community checks

### Short Solo Passes:

- Shall be supervised by staff at any time he is away from the residence, except as follows: case manager may authorize Short Solo Passes in addition to Short and Long Peer Passes and Short and Long Passes with an Approved Other as described in the policy
- The resident shall carry a GPS tracking device that is reviewed upon the resident's return to the facility
- Staff shall conduct random community checks
- Resident shall not have more than 2 passes of any type per day

## VA Special Conditions

- If XX receives any mental health services at the Dept. of Veterans Affairs (VA), his/her case manager shall maintain regular contact with the VA to monitor his/her progress and have in place a procedure by which he/she is promptly notified of any failure by XX to keep an appointment



## Victim Special Conditions

### No Contact Conditions:

Male:

- o No contact with persons specifically identified on a list maintained by his CR supervisor
- o Client shall sign that list to acknowledge his awareness of the identity of those persons with whom he shall not have contact.

Female:

- o No contact, in any form, with persons specifically identified on a list maintained by her CR supervisor
- o Client shall sign that list to acknowledge her awareness of the identity of those persons with whom she shall not have contact.

Family member:

- o Client shall not initiate contact w/any family member. Case manager shall monitor any contact

No Contact or Attempt to Contact:

- o Shall not attempt to contact [person], or any member of [person's] family, or attempt obtain information about them, in any form or by any means

### Movement Restrictions Special Conditions

*(Typically because of victim location or other relationships that could destabilize the client's mental health)*

- o Client may not enter [city, county, etc] except to pass through for [x]
- o **Example:** Client shall not enter Benton County except in a motor vehicle operated by someone other than himself on a public highway for the purpose of travel through Benton County.
