How Do I Apply?

Choose one option:



How Do I Qualify?



- ▶ Be at least 18 years or older and receive one of the following benefits:
 - Supplemental Nutrition Assistance Program (SNAP)
 - Supplemental Security Income (SSI)
 - Medicaid
 - Federal Housing Assistance (Section 8)
 - Veterans or Survivors Pension
 - Or total household income is at or below 135% of the Federal Poverty Guidelines
