
Telecommunication Devices Access Program Catalog



The Oregon Public Utility Commission's Telecommunication Devices Access Program loans specialized communications equipment at no cost and with no income guidelines to qualifying Oregon residents (ages 4 and up). The equipment is designed to support the communication needs of Oregonians with a disability in hearing, speech, vision, cognition or mobility.

Applying is easy!

- 1. Select your equipment by using this catalog (one piece of equipment per applicant).
 - Each equipment will have a symbol(s) that represents the type of disability it is designed to support.
 - Each equipment also has an order number for you to write on the enclosed application in section B.



2. Complete the enclosed application, including certification of your disability in section D, and return it to us. Once approved, you will receive a letter within 1 to 2 weeks to let you know when to expect delivery of your equipment.

If additional support is needed with the equipment, please contact us for information on available accessories.

If we have concerns with your application, we will contact you.

Depending on the model, CapTel provides access to the Captioned Telephone Service or Internet Protocol Captioned Telephone Service for individuals whose hearing loss requires captions to communicate over the phone. The individual speaks to the other person, listens and reads the captions on the screen. A live operator may be used to generate the captions of what the other person on the call says.

Recipients of the internet based CapTel models may be required to register to use Internet Protocol Captioned Telephone Service, which is funded through a federal program.

In many cases, an amplified phone meets the individual's needs.
