### Oregon Racing Commission May 7, 2013

#### Meeting Detail

The Oregon Racing Commission (ORC) met on Tuesday, May 7, 2013 in Room 1E of the Portland State Office Building located at 800 NE Oregon Street, Portland, Oregon.

#### Call to Order

##### **Executive Session:**

The ORC went into Executive Session under ORS 192.660(2) (a) to discuss the progress regarding appointing the next ORC Executive Director at 9:35a.m.

The Commissioners came out of Executive Session at 2:00p.m.

Commission Chair, Chris Dudley, called the public portion of the meeting to order at 2:03pm.

c. Budget and Hub Funds

Commissioner Robson stated that Nancy Artmann did a great job on the budget report. He stated that the sub-committee had met and made decisions regarding the hub fund allocation requests. He stated that there were some changes because of the actual amount of funds available. Commissioner Robson asked that the Allocation Plan be passed around so all could view how the funds were allocated. He stated that the allocation recommendations are as follows:

- Eastern Oregon Livestock Show will receive \$120,287.00 for 2013-2015
- Southern Oregon Horse Racing Association will receive \$502,517.00 for 2013-2015
- Crooked River Round-Up will receive \$182,607.00 for 2013-2015
- Tillamook County Fair will receive \$180,767.00 for 2013-2015
- Harney County Fair will receive \$118,687.00 for 2013-2015

Commissioner Robson stated that the sub-committee is happy to see the associations and Portland Meadows (PM) working together through the Future of Racing in Oregon Group (FROG). He stated that s requested by the hub funds application submitted from FROG, the associations will receive the same amount that they each received last year and PM will receive the increased amount of \$375,000.00.

**Contested Cases:**

**Proposed Order: Don Murphy**

Assistant Attorney General Kelly Gabliks presented the proposed order. She stated that Mr. Murphy owned a horse by the name of "Rachael My Love." She was a two year-old and needed to complete two qualifying workouts in order to be eligible to begin her racing career. She only had completed one official workout. Mr. Murphy entered "Rachael My Love" in a race and needed to get the second workout completed in order for her to be eligible to run in the race in where she was entered. There was not enough time to get the workout done so Mr. Murphy used a different horse. He wrapped her legs and used blinkers that gave the impression she was "Rachael My Love." The Clocker discovered this during the workout and the stewards imposed disciplinary action.

Ms. Gabliks explained all the options that could be imposed by the Commission and the recommendations by the Administrative Law Judge (ALJ).

ORC Presiding Steward Martin Hamilton explained the Steward's ruling and the intent of the ruling to the Commissioners. The ruling called for suspension of all the ORC licenses that Don Murphy has for one year (365 days). The Stewards recommendation is to revoke or suspend his trainer's license for an extended period of time beyond one year.

**Action:** Motion to approve an amended proposed order in the matter regarding Don Murphy to revoke his trainer's license for three years and all other licenses are suspended for 365 days as per the Stewards ruling.

Don Murphy gave testimony to provide the Commissioners his interpretation of what happened to cause the ruling against him.

Will Alempijevic General Manager of Portland Meadows (PM) thanked the Commissioners for expeditiously approving the hub fund allocations. He also thanked them for allowing FROG to submit a request on behalf of all the associations and PM.

Rod Lowe of Southern Oregon Horse Racing Association (SOHRA) was present to thank the Commissioners on behalf of the fairs for the hub fund allocations that were approved. He also announced that a long-time horseman, Carl Alleman, had passed away. He was 94 years-old and had always been very active in racing. Mr. Lowe stated that the family is having a celebration of life for him on the 25<sup>th</sup> of May.
