Discussion and possible approval to amend race meet license for Portland Meadows (PM):

Will Alempijevic, General Manager of Portland Meadows presented the request to amend PM's license by phone. He stated that the request is to add one day of live racing on August 17, 2014. He stated that PM would like to use this day to kick off the 2014-2015 race meet. He reported that the Bar-B-Que (BBQ) cook off event is scheduled on August 16th and 17th. Last year this event was a very big success and that it will be a great venue to promote the 2014-2015 live racing calendar. He stated that the BBQ is a two day event and that PM has reserved a 20 foot movie

screen to show the movie "Sea Biscuit" on the evening of August 16th with live racing to follow on August 17th.

Commissioner Huber stated that he has concerns regarding horse safety. He asked if the track condition was ready for racing. Mr. Alempijevic stated that the track is ready. ORC Executive Director, Jack McGrail stated that the ORC Stewards met with PM track staff to discuss the details of the track's condition to ensure that it is ready.

Randy Evers, Executive Director of the Oregon Horsemen's Benevolent and Protective Association (OHBPA), Lynnelle Smith, Executive Director of the Oregon Thoroughbred Owners and Breeders Association (OTOBA) and Leah Nelson, Association Secretary of the Oregon Quarter Horse Racing Association (OQHRA) stated that they are all in support of the added day.
