

Minutes Oregon Racing Commission June 23, 2022

Meeting Detail

The Oregon Racing Commission (ORC) met at 1:30 p.m. Thursday, June 23, 2022, in Room 1A of the Portland State Office Building, 800 N.E. Oregon St., Portland, OR.

Old Business:

Executive Director's Report

Director McGrail reported that the Eastern Oregon Livestock Show got the season off to a good start, with the track in good shape and improved facilities. He noted that Sunday's card was canceled after heavy rain Saturday night made the track unsafe. Purses were paid out for races that did not go, based on the premise that most horsemen traveled a long way to get to Union.

The Southern Oregon Horsemen's Racing Association (SOHRA) in Grants Pass has had a good start to its seven days of racing, Director McGrail stated. Two members of the Secretary of State's audit team attended the races this week, chaperoned by Program and Administrative Coordinator Karen Parkman. They watched pre-race exams and a barn search by the investigators, went to the gate, the steward's stand and the backside – gaining an overview of what goes into operating a race meet.

The Oregon Horsemen's Benevolent & Protective Association (OHBPA) is working hard to bring a commercial meet back to Oregon. Noting this is his last report as Executive Director, Director McGrail thanked the Commission and stakeholders for their support over the years, adding all shared the same goal of supporting horseracing in Oregon.

New Business:

Review and Possible Approval of HRA LLC License

ADW Supervisor Connie Winn prefaced her remarks by noting Randy Boden and Ron Sutton of OHBPA and Rod Lowe of SOHRA had put together a nice packet in the face of what initially may have seemed insurmountable odds. A few items are pending -- liability insurance policy, jockey insurance policy and bond -- but Ms. Winn noted they are not needed until 30 days before the race meet starts. She recommended approval with the provision that those policies be in place 30 days before the meet.

Review and Possible Approval of Totalizator License Renewals

Supervisor of Pari-Mutuels Dawn Rome reported that applications for the five totalizator companies were complete with the exception of I-Neda Ltd., which is pending a set of fingerprints and background check. She recommended approval of all applications, except for recommending a conditional approval for I-Neda.

Chair Conde recommended delaying the I-Neda Ltd. approval until next month, after the pending documents are received, but Ms. Winn noted that would in effect put the company out of business for the first part of July. She noted that the pending documents were for a person new to the company, and recommended conditional approval provided the documents arrive within a reasonable time.

Review and Possible Approval of ORC Tribal Consultation Policy

Chair Conde stated that he, Director McGrail and Ms. Winn had met with several tribal representatives over the past year and come up with a policy he feels is a vast improvement over previous written policies.

Commissioner Williamson asked if, for example, the Commission failed to consult with a tribe because it did not know of tribal interest in an issue, whether that failure would potentially invalidate the Commission action. Chair Conde responded there was no such provision, and Ms. Winn added that as long as the Commission acts in good faith and tries to keep communication open, there should be no issue.

Commissioner Williamson added he was in favor of consulting with the tribes but wanted to be certain the Commission's regulatory ability was not compromised.

Director McGrail noted those concerns had been raised with counsel. There is no provision in the policy that would invalidate Commission action, he added.

Public Comment:

Randy Boden of OHBPA thanked the Commission for approving the license for HRA LLC, as well as Rod Lowe, Connie Winn and Lynnelle Smith of the Oregon Thoroughbred Owners & Breeders Association (OTOBA). He also expressed his appreciation to Director McGrail for his work over the years.

Lynnelle Smith of OTOBA delivered the group's key statistics report. She noted that at the end of the fiscal year, OTOBA will issue bonus checks to owners of Oregon-bred Thoroughbreds that competed at last fall's commercial meet in Grants Pass. OTOBA has received sponsorships from the Cow Creek Band of Umpqua Tribe of Indians and the Confederated Tribes of Grand Ronde. At the request of the sponsors, that money is being used for starting bonuses for Oregon-breds at the Grants Pass fair meet. That enabled OTOBA to use hub funds to pay starting bonuses for Oregon-breds at another fair meet. OTOBA will pay an additional \$500 to Oregon-breds starting at either Eastern Oregon Livestock Show, Crooked River Roundup or the Tillamook County Fair, as well as adding \$2000 to each Oregon-bred race at the fairs. Ms. Smith also thanked Director McGrail for his support of Oregon breeders and owners through the years.

Commissioner Williamson noted this was also Vice Chair O'Hagan's last meeting and thanked him for his contributions to the Commission. Chair Conde and Director McGrail seconded that.

Chair Conde noted the Commission had a plaque to present to Director McGrail in recognition of his service, and praised his dedication and mentorship. Commissioner Williamson noted Vice Chair O'Hagan also deserved a plaque, and Chair Conde agreed.
