By submitting this application, I, the undersigned, hereby (i) agree to abide by the rules and regulations of the pari-mutuel regulatory agency of the State of Oregon, ORS 462.010 – 462.990, the laws of the United States of America, Canada, all state/provincial governments, municipalities and other sub-divisions thereof; and (ii) agree to abide by any provision regarding search, within the grounds of a racetrack or racing association, of any premises or vehicle that I may occupy or control or have the right to occupy or control and my person, property, and effects and in the seizure of any article the possession of which may be forbidden. All submitted applications are considered temporary until the criminal background is completed and the application is approved by a Steward.

PRIVACY ACT STATEMENT
