Clark was licensed as a principal broker with 14 Realestate.com Oregon (Realestate.com). 15 1.2 On September 30, 2011, OREA discovered that Realestate.com was no longer 16 located at the address they had on record with OREA at 10001 SE Sunnyside Rd #200. 17 Clackamas, Oregon. The phone number on record with OREA was disconnected. 18 On July 1, 2011, Realestate.com moved their office to 24066 NE Treehill Drive, 1.3 19 Troutdale, Oregon, but did not properly notify OREA. 20 **CONCLUSIONS OF LAW** 21 2. 22 From July 1, 2011 until October 21, 2011, Clark was conducting real estate activity at a 23 physical location without proper notification to OREA. 24 Violation: ORS 696.200(1)(d) (2011 Edition), which requires that a principal broker 25 notify the agency before changing a main office location on a form approved by the agency. 26 3. 27 3.1 OREA reserves the right to investigate and pursue additional complaints that 28 may be received in the future regarding this licensee. 29 3.2

ORS 696.301 states that violations, such as those defined above, are grounds

for discipline.

I hereby agree and stipulate to the above findings of fact and conclusions of law and understand that the order which follows hereafter may be completed and signed by the Real Estate Commissioner or may be rejected by the Real Estate Commissioner, in which case an amended notice of intent may be issued in this matter. I understand that, pursuant to ORS 696.445(3), notice of this order shall be published in the Oregon Real Estate News Journal.

ORDER

IT IS HEREBY ORDERED that Clark be, and hereby is, reprimanded. **In addition**, Clark must complete the Broker Administration and Sales Supervision (BASS) course within 120 days of the date of this Order, and must notify OREA in writing and provide proof, such as a course certificate, when he has done so.
