2	Jason Shaner, River's Edge Towing Hood River, Oregon	1 st Term: 09/01/2022 – 06/30/2023 2 nd Term: 07/01/2023 – 06/30/2027	A tower who holds a towing business certificate issued under ORS 822.205 (Certificate) and who represents a city in Oregon with a population of less than 100,000;
3	Kevin Baker, Baker & Baker Towing Woodburn, Oregon	1 st Term: 09/01/2022 – 06/30/2024 2 nd Term: 07/01/2024 – 06/30/2028	A tower who holds a towing business certificate issued under ORS 822.205 (Certificate) and who has specialized knowledge in towing equipment and vehicles with a gross vehicle weight rating of more than 44,000 pounds;
4	Gary McClellan, Ray's Towing Eugene, Oregon	1 st Term: 09/01/2022 – 06/30/2025	A tower who holds a towing business certificate issued under ORS 822.205 (Certificate) and who has specialized knowledge in towing vehicles with a gross vehicle weight rating of 26,000 pounds or less;
5	Trent Hanson, CIC HUB International Northwest Corvallis, Oregon	1 st Term: 09/01/2022 – 06/30/2023 2 nd Term: 07/01/2023 – 06/30/2027	A representative of the insurance industry who is a: <ul style="list-style-type: none"> Licensed Property and Casualty Agent, adjuster or underwriter with a working knowledge of insurance as it affects the towing industry (including on-hook coverage.) Certified Insurance Counselor, or other accredited or credentialed insurance professional specializing in risk assessment and management, liability, and property-casualty insurance.
6	Lt. Jason Lindland, Oregon State Police Salem, Oregon	1 st Term: 10/03/2022 – 06/30/2026	A sworn officer from the Oregon State Police Tow Program.
7	Vacant		An Oregon chief of police or county sheriff.
8	Chuck Riley Hillsboro, Oregon	1 st Term: 09/01/2022 – 06/30/2024 2 nd Term: 07/01/2024 – 06/30/2028	A member representing Oregon's general public and who <ul style="list-style-type: none"> Does not meet the requirements of any of the other appointed board positions; and Is able to objectively represent the concerns and needs of the general public related to towing operations and regulations within the State of Oregon.
9	Chris Coughlin, Policy Director Oregon Consumer Justice Portland, Oregon	1 st Term: 09/01/2022 – 06/30/2025	A consumer advocate who demonstrates: <ul style="list-style-type: none"> Familiarity with consumer education and outreach; Volunteer or professional experience in the field of consumer advocacy, which might include but is not limited to legal, policy, or education; and General knowledge of relevant Oregon consumer protection laws.
