

State Board of Towing How to Apply for a Board Member Position

OVERVIEW:

- The State Board of Towing was established by the 2021 Oregon Legislature under Senate Bill 300 to implement ORS 98.853 to 98.962, and to administer other laws assigned to the Board.
- The Board consists of nine board members, appointed by the Governor for four-year terms.
- The Governor may re-appoint Board members to serve consecutive terms.
- The Governor appoints new board members at the beginning of a term or to fill a vacancy.

INTERESTED CANDIDATES:

Candidates seeking appointment for a board member position must:

- Be a resident and taxpayer of the State of Oregon;
 and
- Meet the requirements of the position seat applied for;
 and
- Submit an online application to the Governor's Executive Appointments Team.

Note: Due to funding and resource limitations, State Board of Towing Members are not compensated with a per diem rate or reimbursement of mileage or other expenses at this time.

APPLICATION PROCESS:

- 1. The Governor makes appointments to over 250 Boards and Commissions representing a broad range of areas and issues for the State of Oregon.
- 2. The Online Application is a basic application that tells the Governor's Executive Appoint team about you, your background, and why you want to participate on a Governor-appointed Board or Commission.
- 3. Only complete applications will be considered. A complete application consists of:
- Contact Information
- Short Personal Bio
- Responses to Application Questions
- Demographic Information

- Uploaded Resume (PDF only)
- Background Check Questions and Voluntary Disclosures
- Additional Tasks (prompted by Workday)
- Applicants may be subjected to a background check and additional vetting for some board positions.
- 4. The Governor's staff will review the completed, submitted applications, and may forward completed applications for the Board's review. The Board may submit a recommendation to the Governor's staff, but the Governor determines who to appoint to a board member position.
- 5. Interested candidates unable to complete the form electronically should reach out to the Executive Appointments Office, executive.appointments@oregon.gov, for assistance.
- 6. The Board is not a part of the initial application process. Resumes, applications or letters of interests should be submitted directly to the Governor's team through the application process.

HOW TO APPLY: EXTERNAL - NEW APPLICANTS

The State of Oregon uses Workday to submit and process online applications.

The Board has no part of the application process or Workday. Questions regarding the application process or Workday access should be directed to the Governor's Executive Appointments team.

HOW TO APPLY: CURRENT WORKDAY ACCOUNT

Current State Employees, Commission or Board members should use their state workday account credentials to submit an application.

Individuals with existing Workday accounts through their place of employment in the private sector will need to contact the Governors Executive Team for assistance if there are issues in creating a State of Oregon Workday account.
