

**SEC - INDEPENDENT REGISTERED MUNICIPAL ADVISOR EXEMPTION
for Calendar Year 2018**

By publicly posting the following written disclosure, the State of Oregon intends that market participants receive and use it for purposes of the independent registered municipal advisor exemption to the SEC municipal advisor rule.
