# Agenda Item 1 - Review and approval of the February 8, 2023, Board Minutes (ACTION ITEM)

**MOTION:** Board Member Jennifer Geller moved to approve the February 8, 2023, Board minutes, seconded by Board Member Missy Olson. The minutes were approved by a 5/0 vote.

### Agenda Item 2 – Investment Recommendations (ACTION ITEM)

Ryan Harvey and Ryan Fitzgerald, Sellwood Consulting, presented the investment recommendations for the Board. The investments in the plan are revisited every five years. Sellwood made the following proposal:

- 1. Adjust the College Enrollment Year Glidepath Design:
  - a. Increase equity at the starting point of the glidepath.
  - b. Update the US & Non-US equity market split to 60% US and 40% Non-US to roughly match the market weighting.
  - c. Remove DFA Global Real Estate Strategy and DFA Commodity Strategy and reallocate to equity and fixed income for a cheaper, more passive approach.

- 2. Adjust the OCSP & ABLE Target-Risk Portfolios:
  - a. Update the US & Non-US equity market split to 60% US and 40% Non-US to roughly match the market weighting.
  - b. Remove DFA Global Real Estate Securities and add Vanguard Inflation-Protected Securities.
- 3. Adjust the Diversified International Option:
  - a. Replace American Beacon International with Dodge & Cox International.
  - b. Add DFA International Small Cap to add additional market exposure.
  - c. Reweight the portfolio for more style and cap balance.

A copy of the Investment Recommendations is part of the records for this Board meeting.

**MOTION:** Treasurer Read moved to approve the Investment Recommendations outlined by Sellwood Consulting, seconded by Board Member Missy Olson. The Investment Recommendations were approved by a 5/0 vote and will go into effect July 1<sup>st</sup>.

Agenda Item 3 – Approval of Updated Investment Policy Statement (IPS) (ACTION ITEM) Ryan Harvey, Sellwood Consulting, presented the updated IPS for the Boards approval. A copy of the changes to the Investment Policy Statement is part of the records for this Board meeting.

**MOTION:** Board Member Jennifer Geller moved to approve the recommended changes to the Investment Policy Statement, seconded by Board Member Sydney Chamorro. The updated Investment Policy Statement was approved by a 5/0 vote.

### Agenda Item 4 – Executive Director's Report (INFORMATION ITEM)

Michael Parker, Executive Director, announced his retirement from State service, and introduced the new Executive Director, Ryan Mann who gave a quick introduction. Mr. Parker reported that staff will be putting together a Board calendar that outlines ongoing requirements that will be brought to the Board and building out a formal Board member orientation. The last meeting the Board had a question around insurance coverage. Mr. Parker stated that the state is required to defend Board members for claims arising out of their normal course of duty under the tort claims by the State of Oregon.
