Executive Director's Summary of Findings

Systemic Areas for Improvements (AFI):

Eastern Oregon University administers a full time Master of Arts in Teaching that incorporates classroom experiences and is masted on the previously approved EOU MAT program. This program is offered in a hybrid format with the majority of courses offered in 5 week mini-terms. During each mini-term, candidates attend an in-person weekend experience and meet synchronously over zoom during the other weeks. The remainder of the coursework is completed asynchronously. Candidates are hired as Assistant Classroom Educators and work with Cooperating Teachers in their classrooms at Springs Charter school in California. The classroom-based experiences culminate in a 15 week student teaching experience which they program states meets the requirements of OAR 584-400-0140 for preservice candidates.

There was some concern with the Danielson Framework used to observe candidates with predominantly high scores at level 2 (proficient) or level 3 (distinguished), for candidates with little experience. One would not expect that most candidates would perform at an "exemplary" level during their first few weeks of teaching. The EPP noted that this is an area of concern since this is a measure designed to evaluate practicing teachers. The recognition by the EPP that this is a concern is a positive indicator, and the rejoinder addressed how they planned to address this issue. For assessment 6, the EPP noted that there were substantial differences between the performance on this measure between year one and year two that could have been attributable to a change in instructor. The rejoinder indicates how the EPP will attempt to understand the influence of instructor on student performance or how they might prevent such a difference from happening in the future.
