My childhood experience influenced my career choice and desire to become a dual language teacher with whom students can create meaningful relationships. As a BIPOC student, I noticed early on the lack of representation of BIPOC teachers within our schools. My hope is for BIPOC students to see themselves reflected within their BIPOC teachers, feel represented within their schools, and in return have better academic outcomes.

## **National Update**



The U.S. Departments of Education and Labor announced July 27, 2023 that they have invested tens of millions of dollars into expanding registered apprenticeship programs for teachers. For the first time, they also highlighted quality control: The labor department issued a set of nonbinding guidelines meant to ensure quality as more states adopt the approach.
