Oregon Law and Finance Course Options for Administrators

Out-of-state administrators seeking an Oregon Principal or Professional Administrator License must complete coursework in Oregon School Law and Oregon School Finance to transition from a Reciprocal Administrator License. Both courses must be completed within 18 months of the issuance of the Oregon license.
