Oregon School administrators moving to Oregon who hold an administrator license in another state are required to complete a 2 semester or 3 quarter credit course in Oregon School Law and Finance to transition from the Reciprocal Administrator license to the Principal or Professional Administrator license. Please contact the university for more details. Both courses need to be completed within 18 months of being awarded an Oregon license. The following chart includes the course offering which will meet the requirement.
