In March of 2020, and again in September of 2020, the Commission responded to Governor Kate Brown's Executive Order regarding the COVID-19 Pandemic. This document addresses a part of the guidance, designed to give relief for licensed educators requiring PDUs to renew a license. The tables below describe temporary changes to numbers of PDUs required to renew and reinstate licenses.
