8	On April 19, 2021, the Teache	er Standard	s and Practices Commission		
9	(Commission) received a misconduct	report fro	m the Winston-Dillard School District		
10	(WDSD), indicating possible professional misconduct on the part of licensed educator,				
11	Isaiyah Kovachy, (Kovachy.)				
12	After review of the matters alleged, Kovachy and the Commission agree that their				
13	respective interests, together with the public interest, are best served by a stipulation to				
14	certain facts and the imposition of a revocation of Kovachy's Oregon educator license.				
15	This Order sets forth the facts upon which the parties have agreed and the				
16	sanction to be imposed. Kovachy stip	pulates tha	t there are sufficient facts contained in		
17	the Commission's files and records to support the findings of fact and conclusions of law				
18	set forth below. In entering into this stipulation, Kovachy waives the right to a hearing to				
19	contest the findings of fact, conclusio	ons of law a	nd order set forth below.		
20	By signing below, Kovachy ac	knowledge	s, understands, stipulates, and agrees to		
21	the following: (i) he has been fully ad	lvised of his	s rights to notice and a hearing to contest		
22	the findings of fact, conclusions of lav	w, and orde	er set forth below, and fully and finally		
23	waives all such rights and any rights	to appeal o	r otherwise challenge this Stipulation of		
24	Facts and Final Order of Revocation ((Stipulation	n and Final Order); (ii) this Stipulation		
25	and Final Order is a public document	t and disclo	sed to the public upon request by the		
26	Commission; (iii) this Stipulation and	d Final Ord	er is contingent upon and subject to		
27	approval and adoption by the Commi	ission. If tl	ne Commission does not approve and		
28	adopt this Stipulation and Final Orde	er, then nei	ther Kovachy nor the Commission are		
29	bound by the terms herein; (iv) he ha	s fully read	this Stipulation and Final Order, and		
30	understands it completely; (v) he volu	untarily, w	thout any force or duress, enters into		
31	this Stipulation and Final Order and	consents to	issuance and entry of the Stipulated		
32	Final Order below; (vi) he states that	no promis	e or representation has been made to		
33	induce him to sign this Stipulation an	nd Final Or	der; and (vii) he has consulted with an		
34	attorney regarding this Stipulation ar	nd Final Or	der and has been fully advised with

1 to entering into this Stipulation and Final Order and issuance and entry of the Stipulated 2 Final Order below.

STIPULATION OF FACTS

1. The Commission has licensed Kovachy since March 2, 2016. Kovachy holds a Preliminary Teaching License, with an endorsement in Advanced Mathematics (PK-12), valid from December 17, 2018, through January 4, 2022. During all relevant times, Kovachy was employed by the Wintson-Dillard School District (WDSD).

2. On April 19, 2021, the Commission received a misconduct report from the WDSD indicating Kovachy had self-reported on approximately March 27, 2021, that he had engaged in an inappropriate romantic/sexual relationship with an 18-yearold female student, "AS." WDSD placed you on leave and initiated an investigation.

3. According to WDSD and TSPC investigative records, on or about March 27, 2021, Kovachy reported to WDSD staff that he was engaged in an inappropriate sexual/romantic relationship with an 18-year-old former student, "AS." Kovachy told district and TSPC officials that "AS" expressed interest in getting to know him better. "AS" transferred to another school. "AS" asked Kovachy on a date, which he at first, declined. Kovachy stated he researched the propriety of dating a former student over the age of 18, but mistakenly concluded that it was acceptable. Kovachy and "AS" began dating and entered into an inappropriate romantic/sexual relationship. Kovachy told officials that he and "AS" will likely marry. This matter was referred to law enforcement for further investigation, however law enforcement declined to prosecute Kovachy as the student, "AS," was over the age of majority. Kovachy resigned his employment with WDSD.

7	incorporates OAR 584-020-0035(1)(b) (Refrain from exploiting professional		
8	$relationships\ with\ any\ student\ for\ personal\ gain,\ or\ in\ support\ of\ persons\ or\ issues),\ OAR$		
9	$584 ext{-}020 ext{-}0035(1)(c)(A)$ (Not demonstrating or expressing professionally inappropriate

14	ORS 342.175.

18	Oregon educator license for a period of one (1) year.
